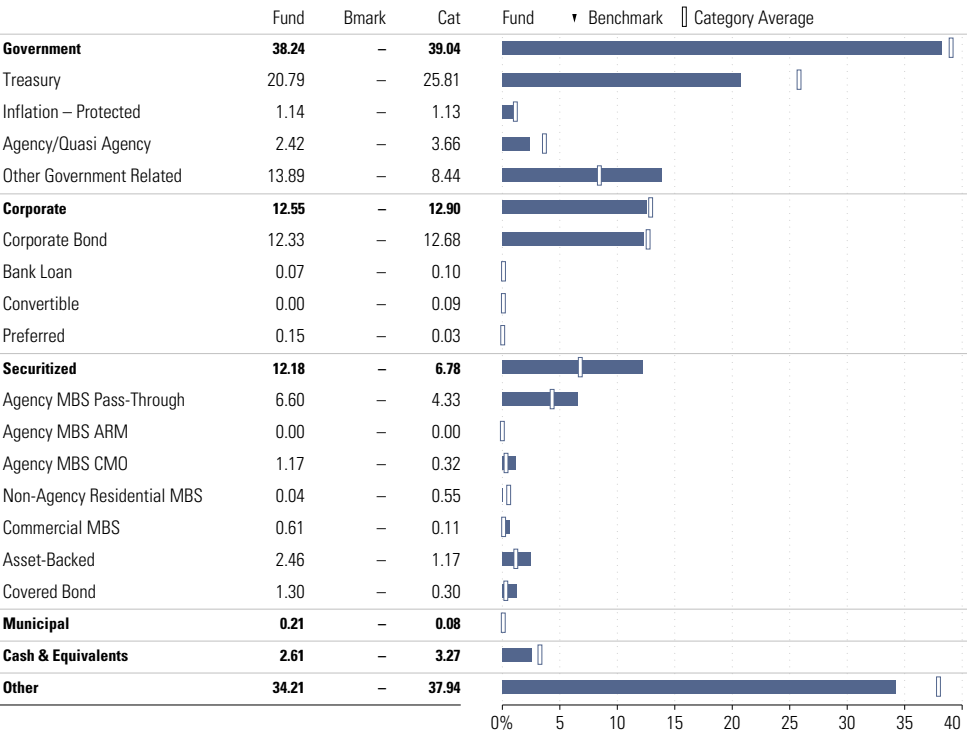

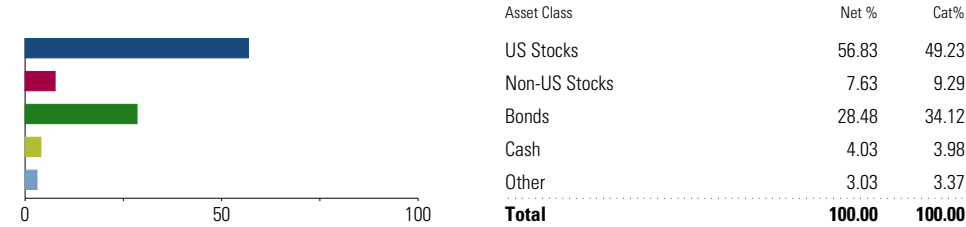

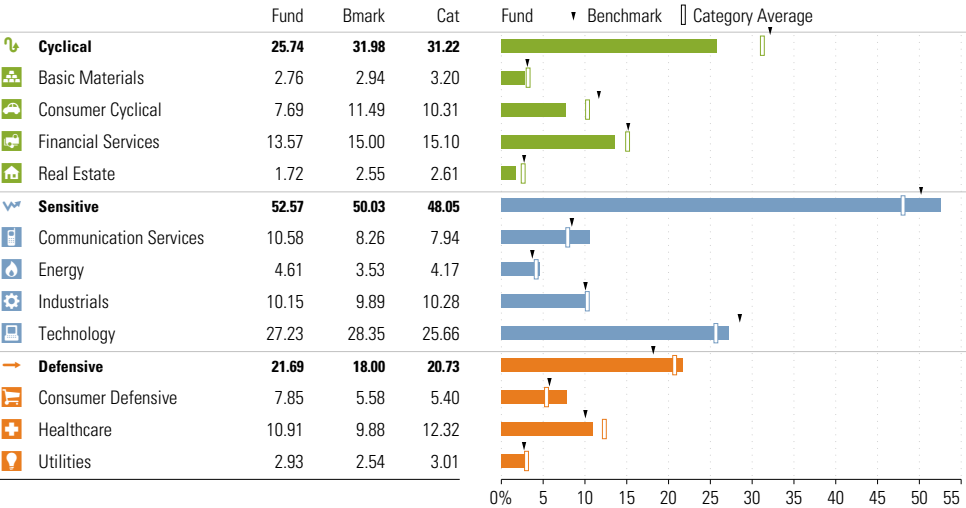

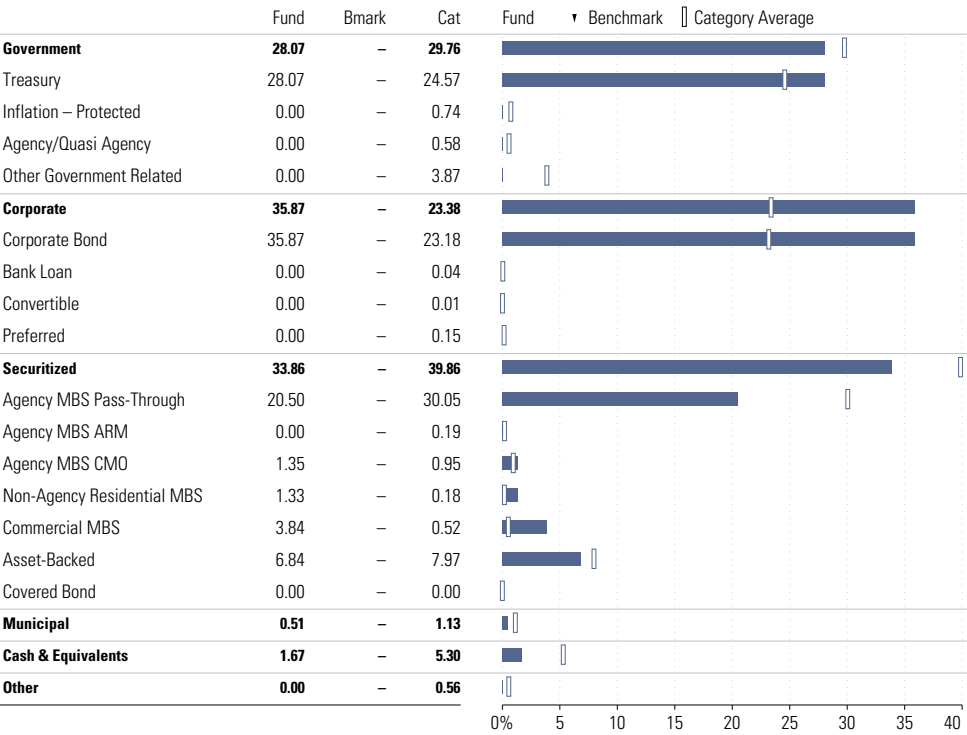

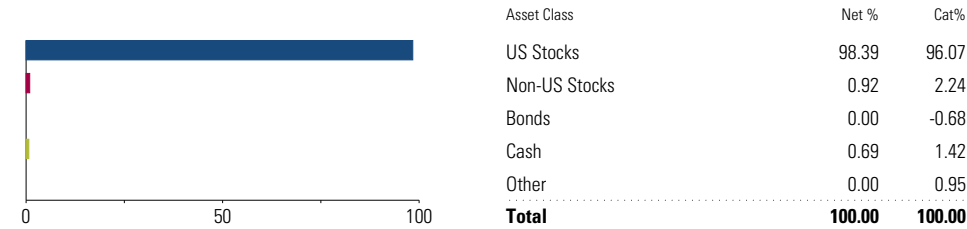

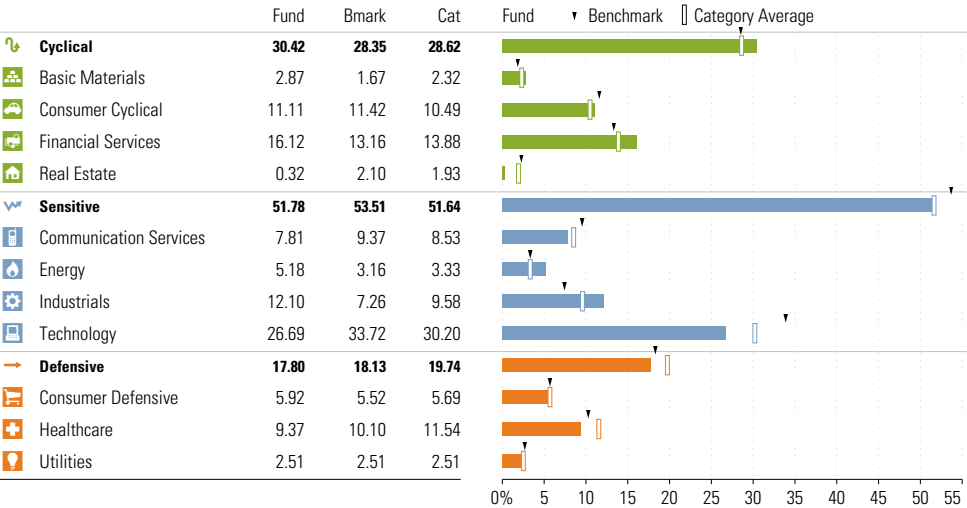

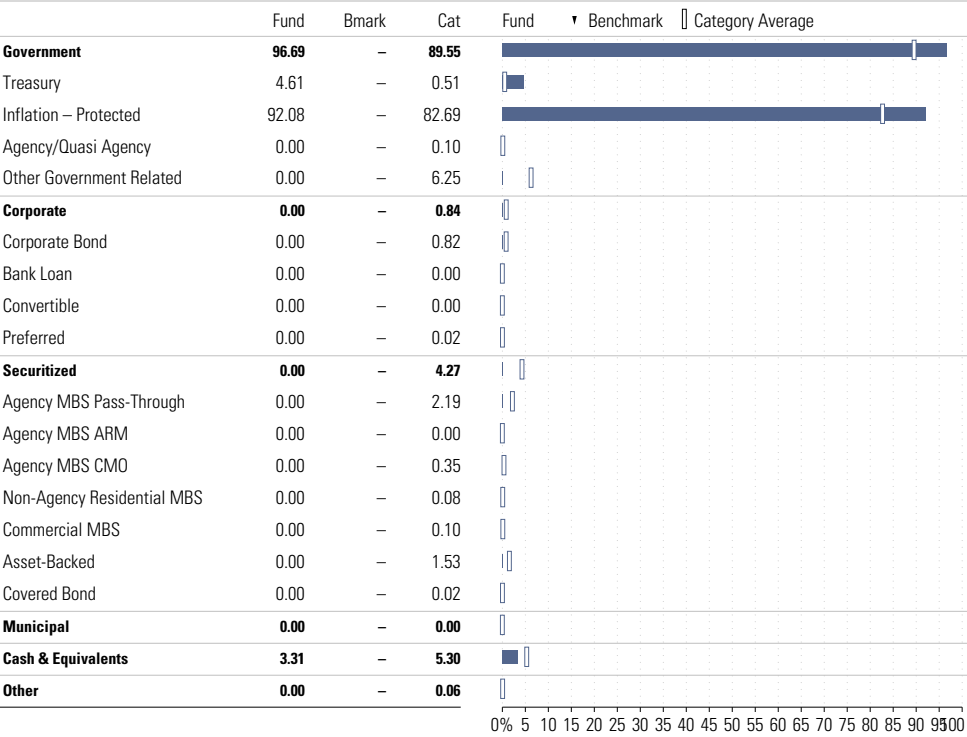

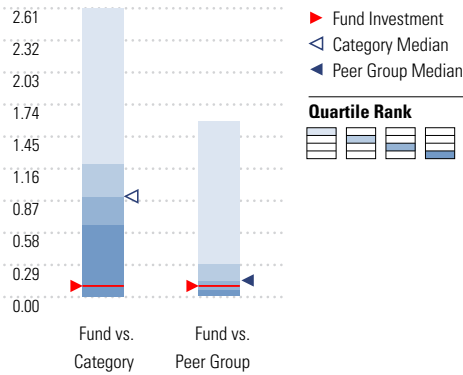

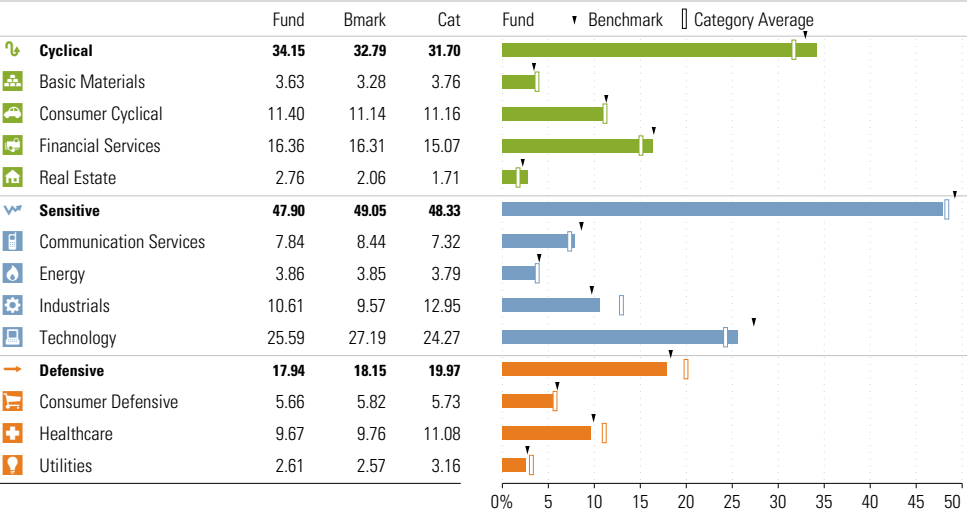

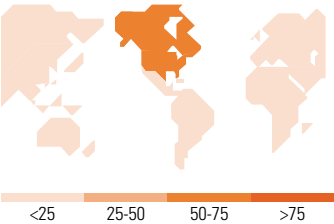

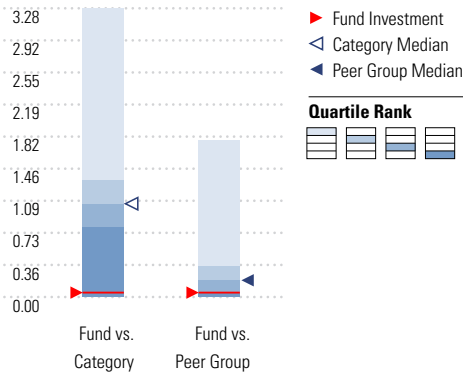

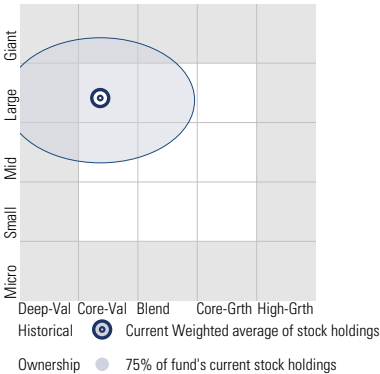

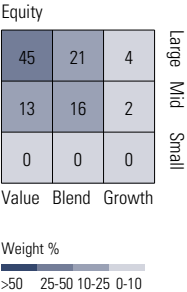

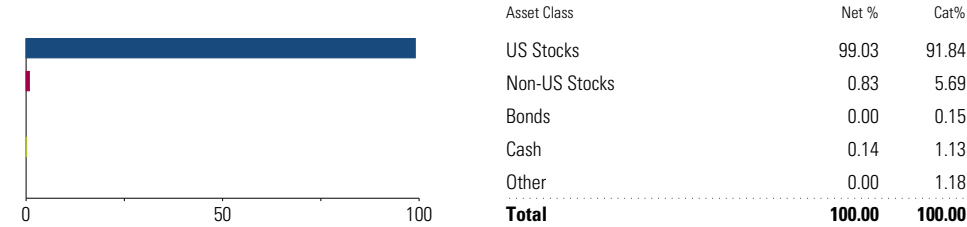

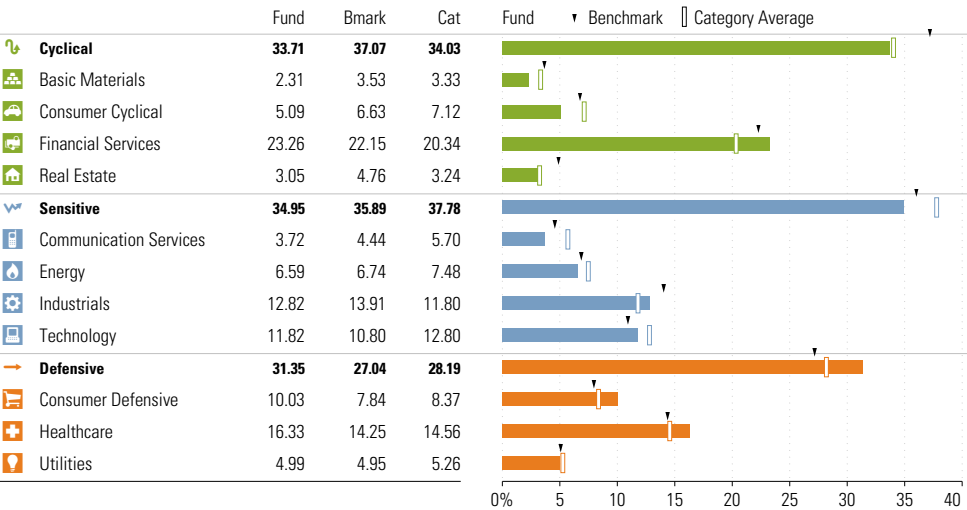
Style Breakdown
