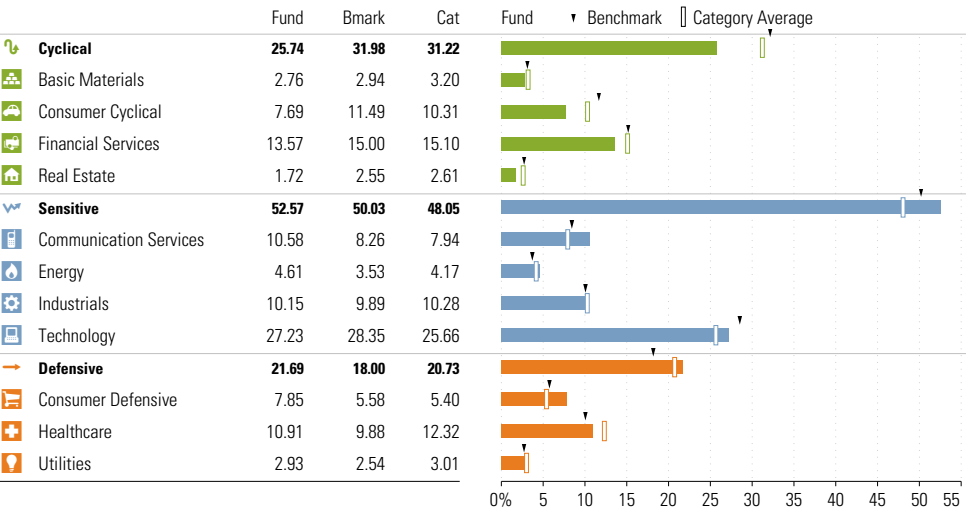

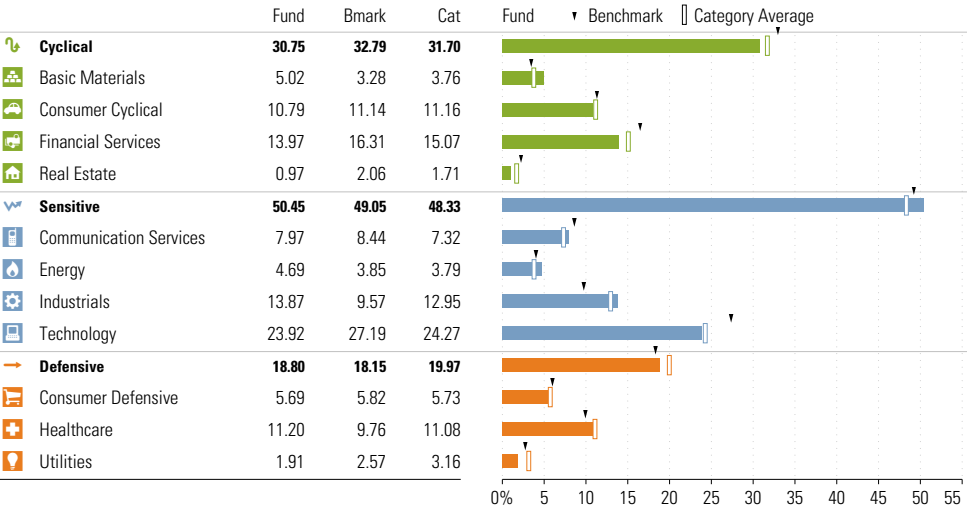

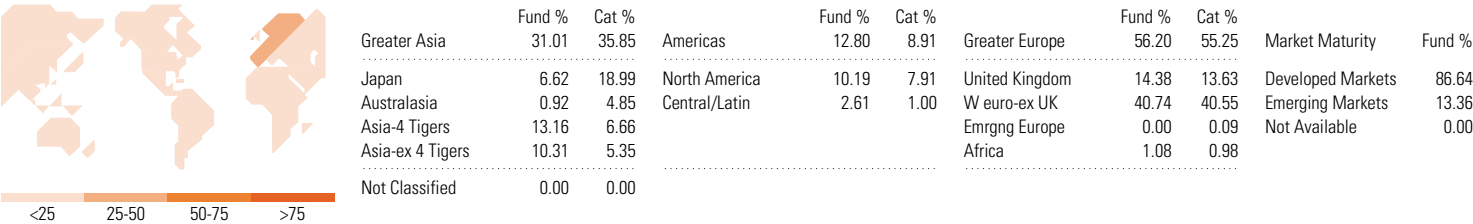
Asset Allocation as of 12-31-2024

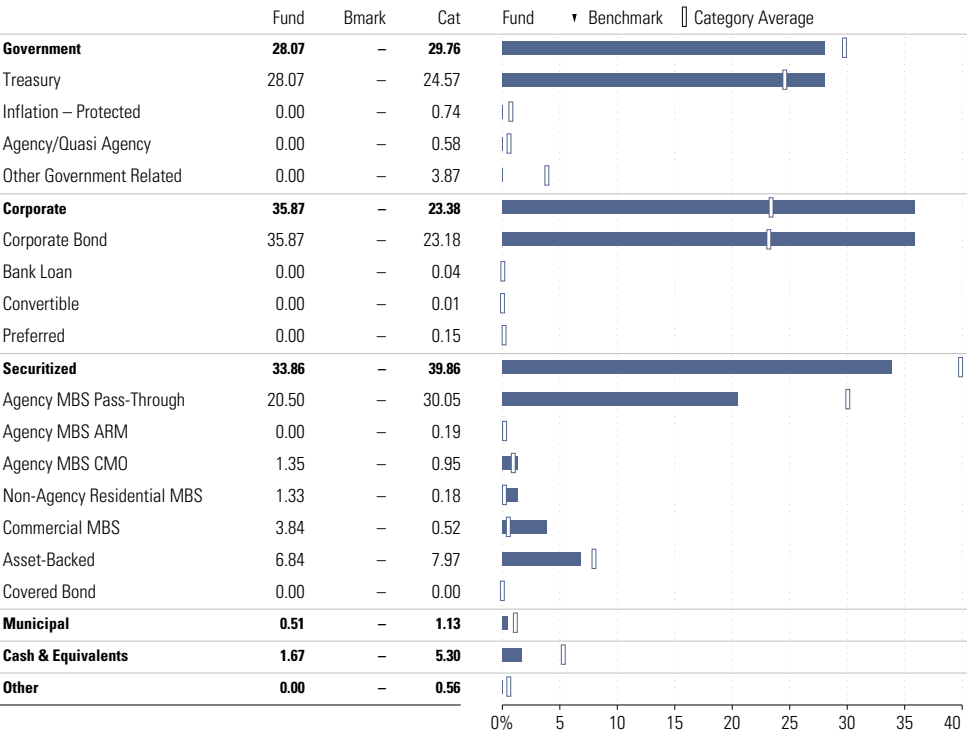

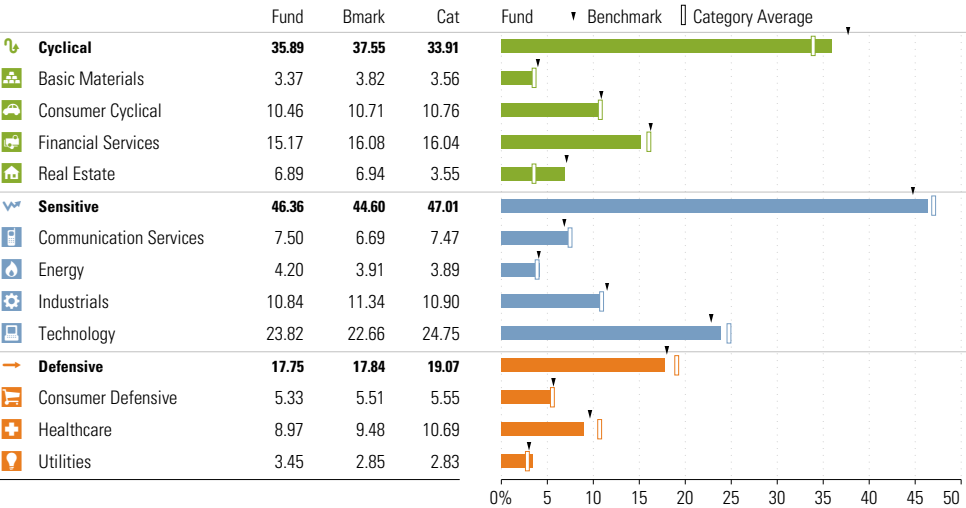
Style Breakdown

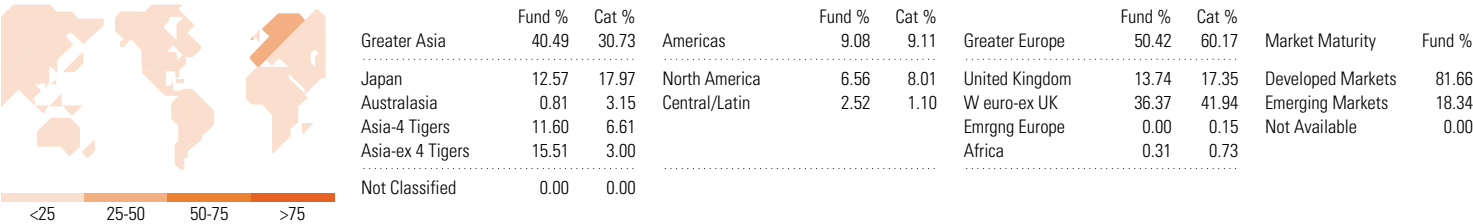
Asset Allocation as of 12-31-2024

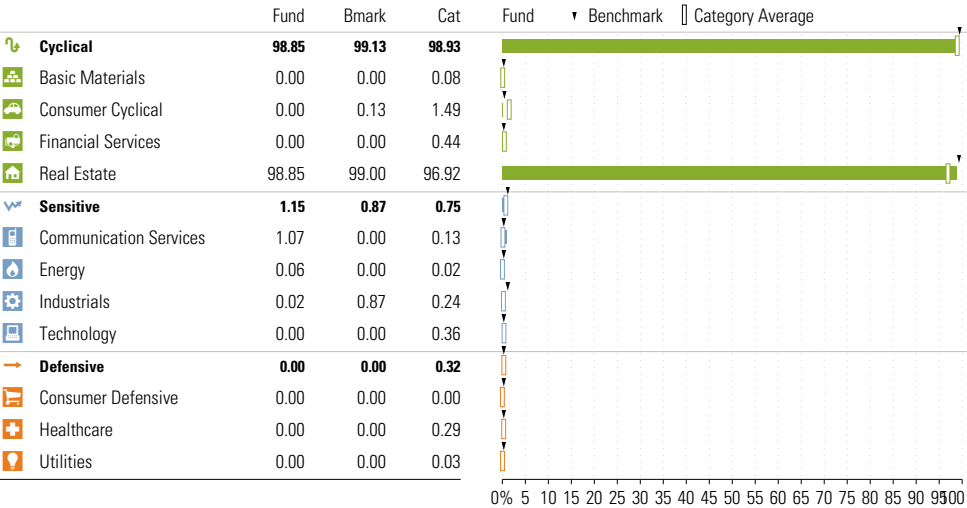

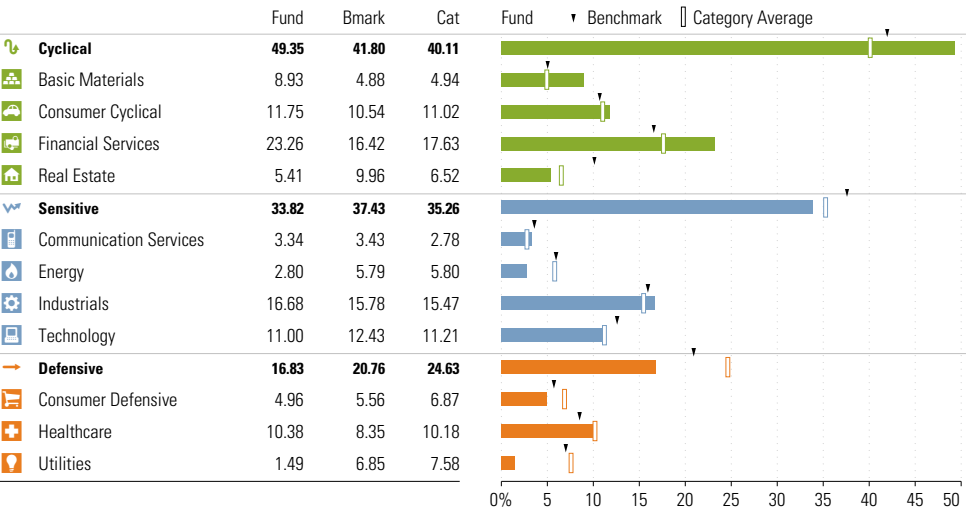

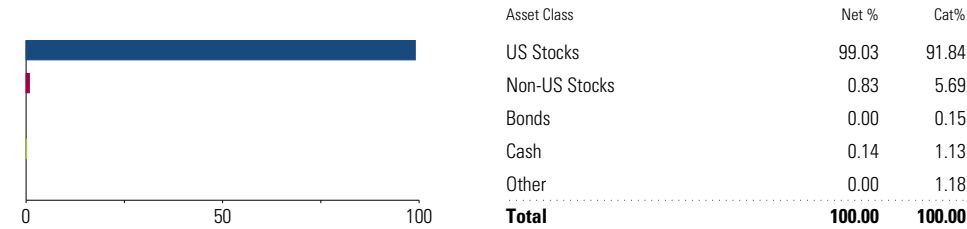

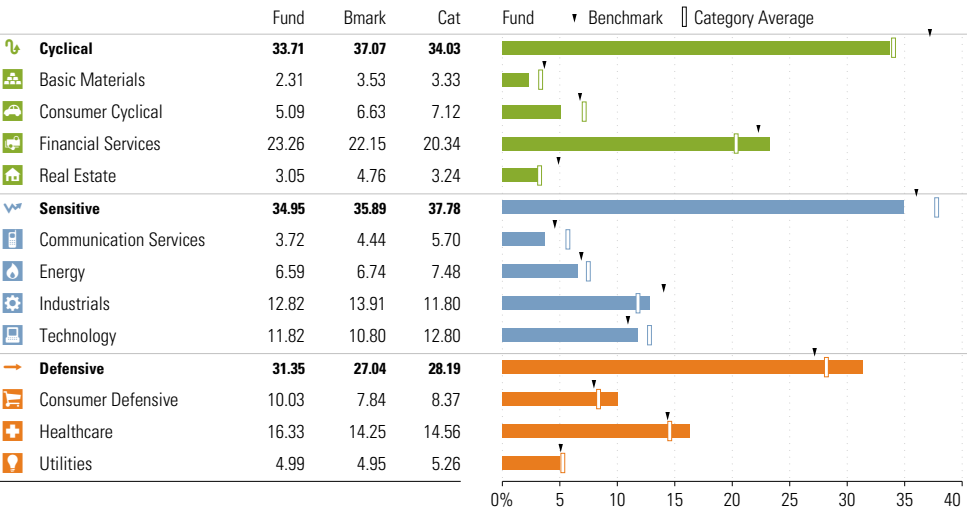
