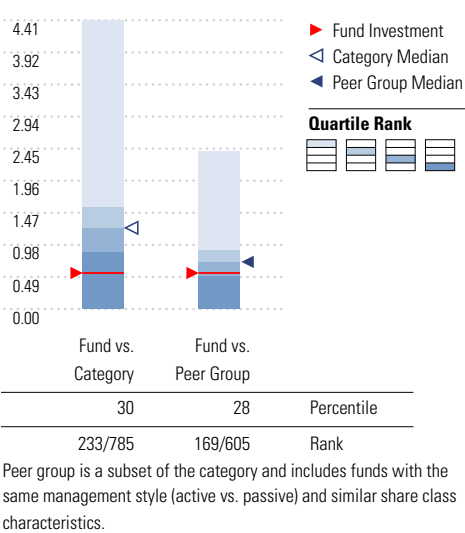

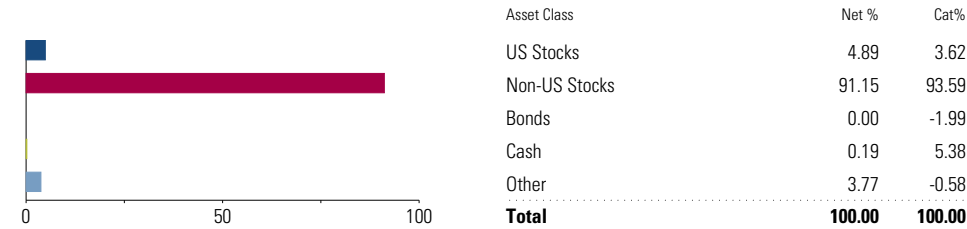

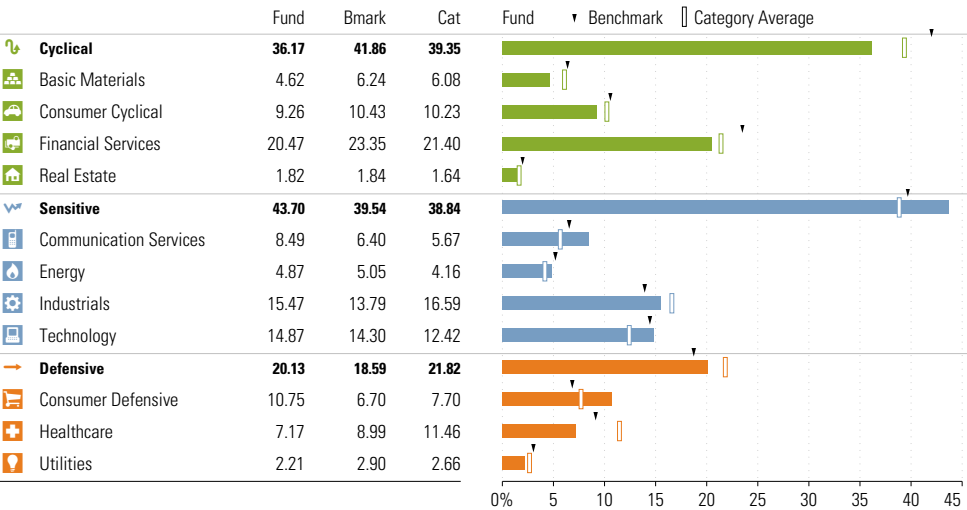

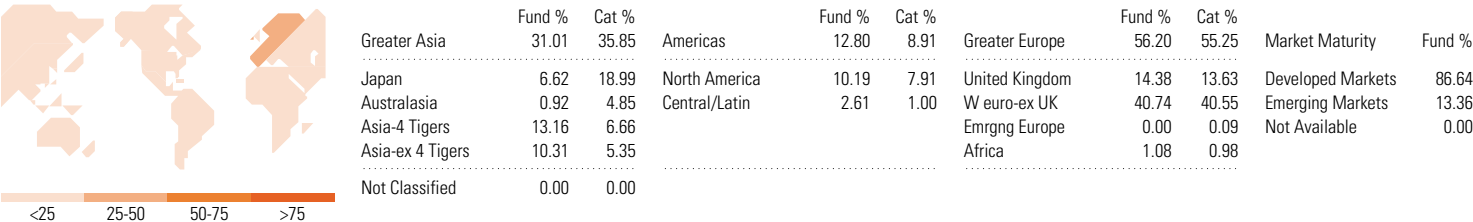

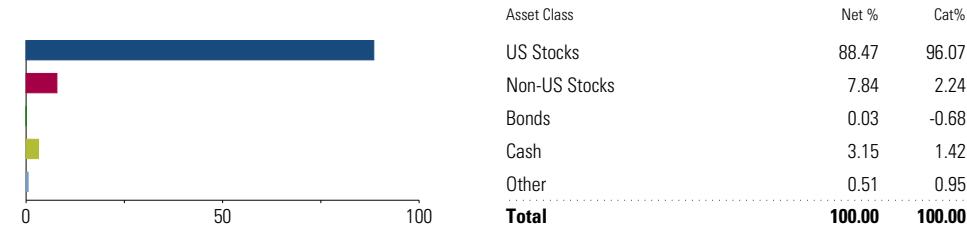

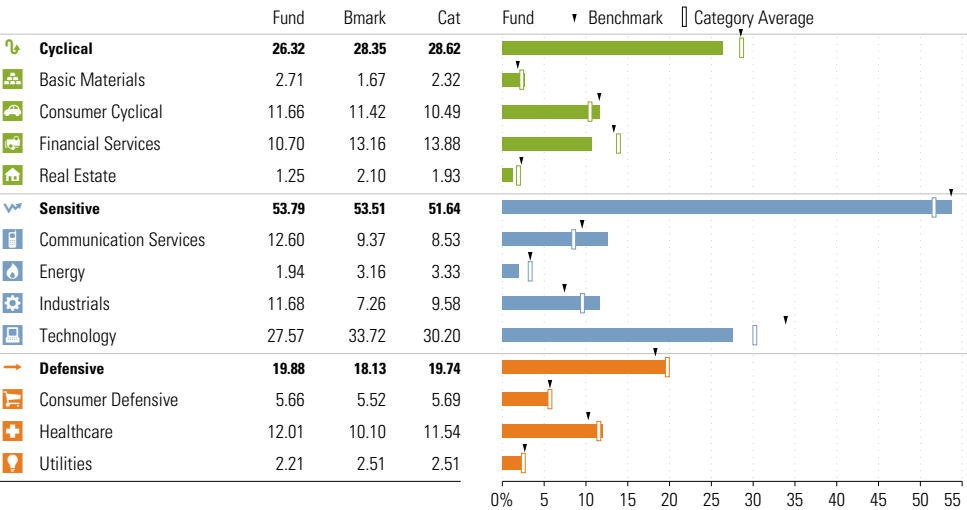

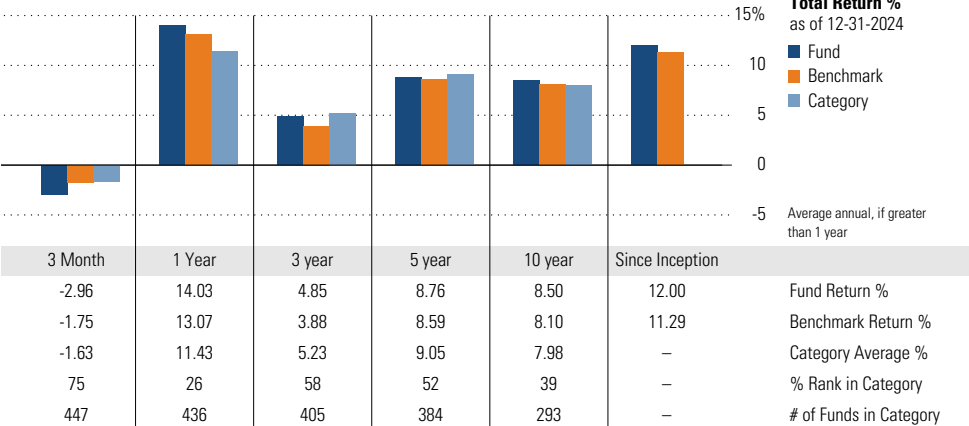

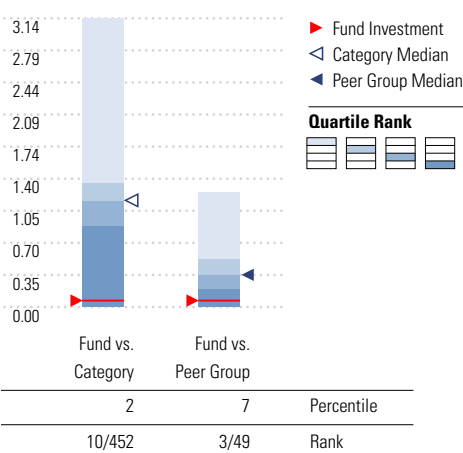

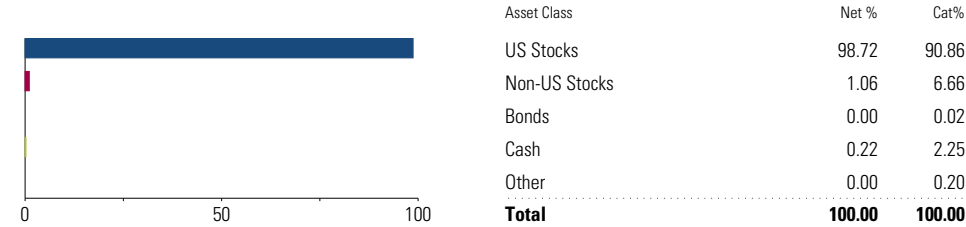

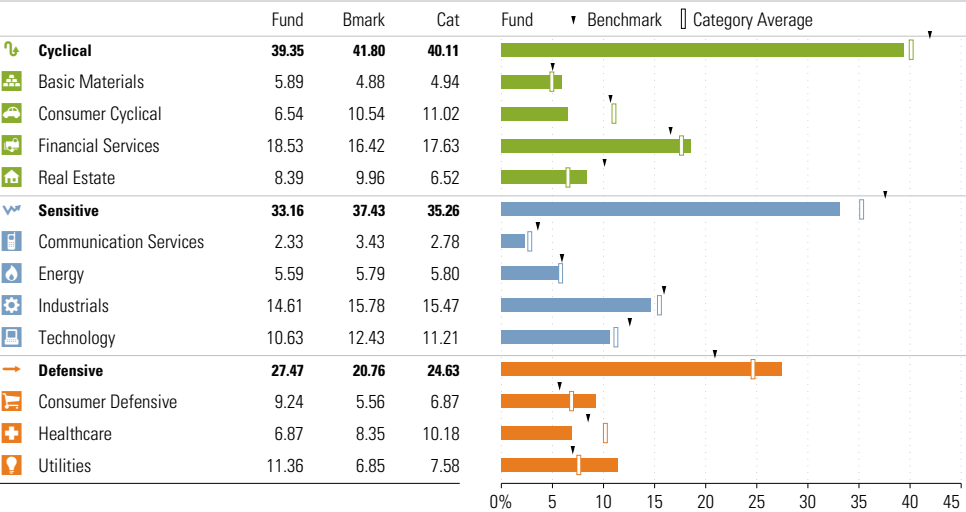
Style Breakdown

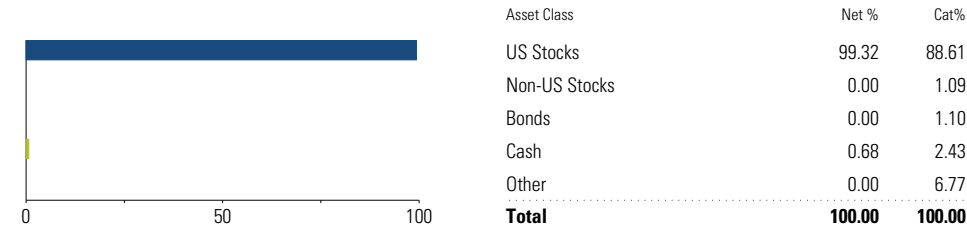

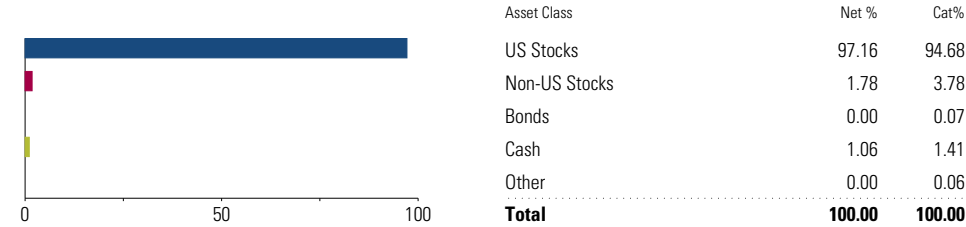

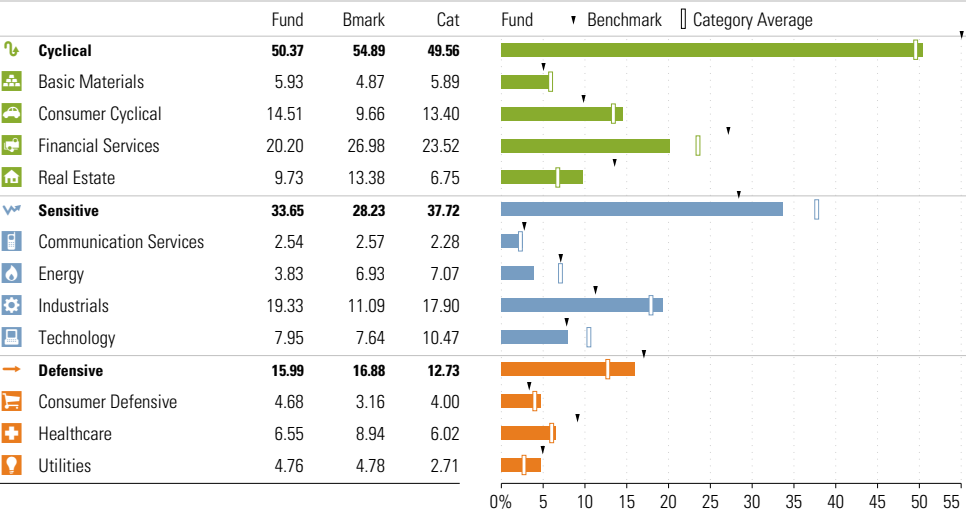
