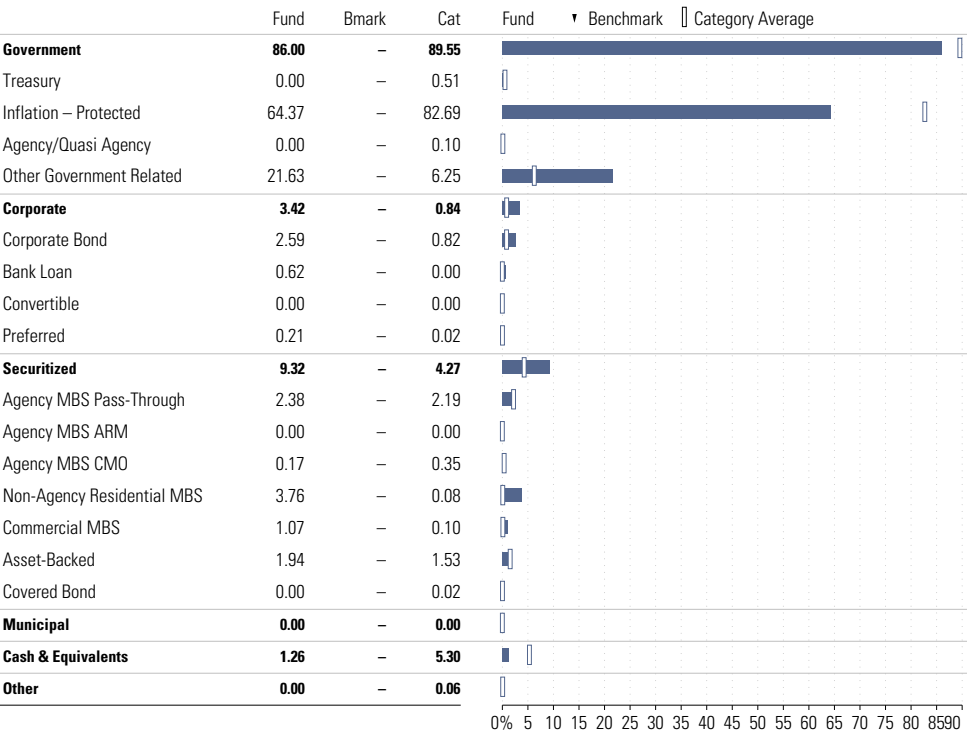

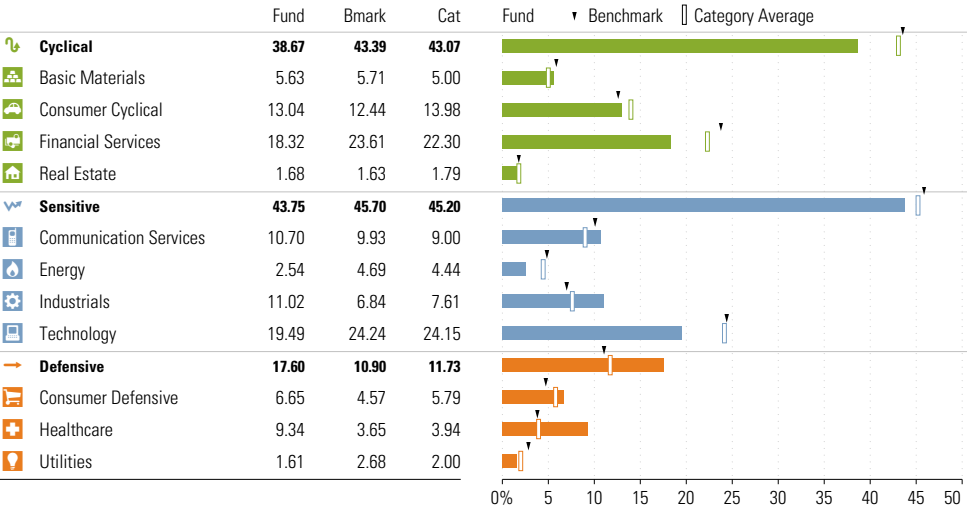

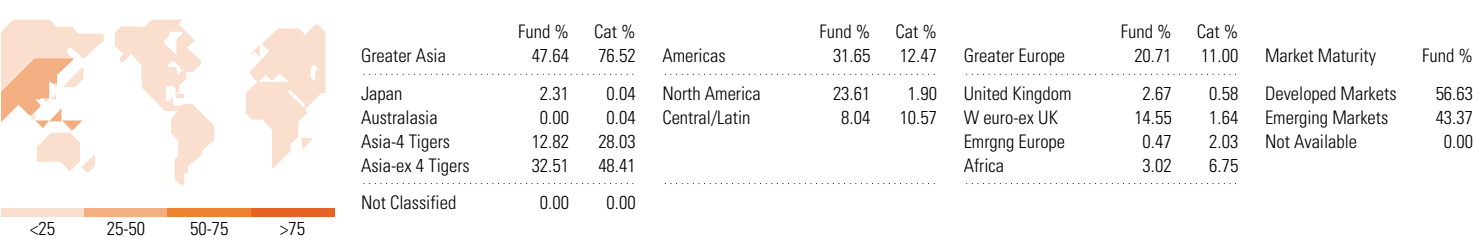

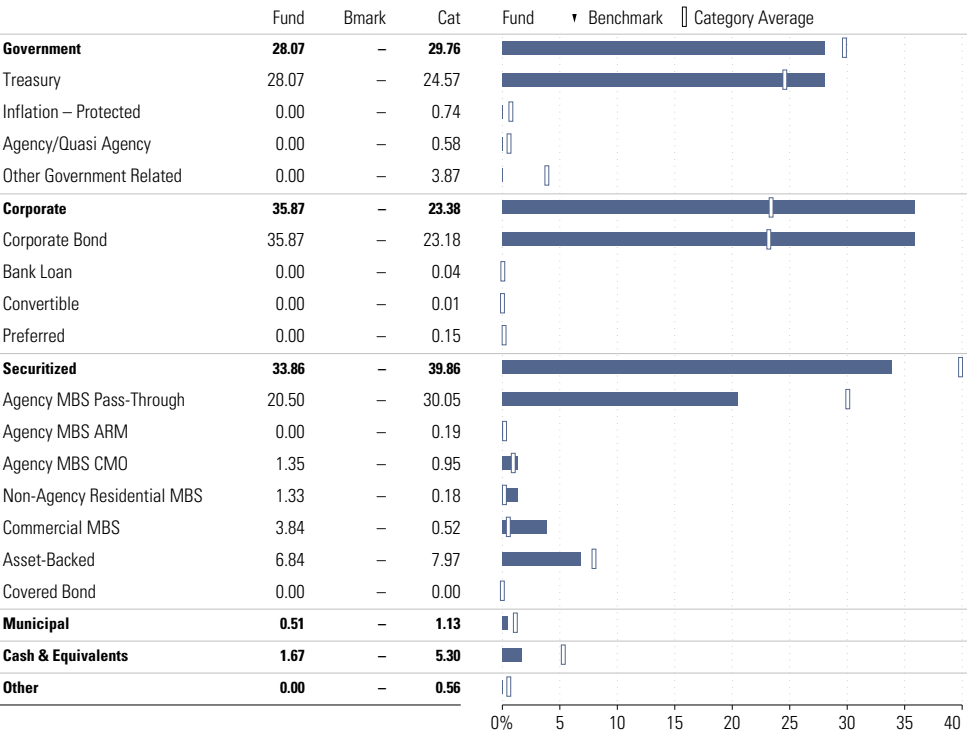

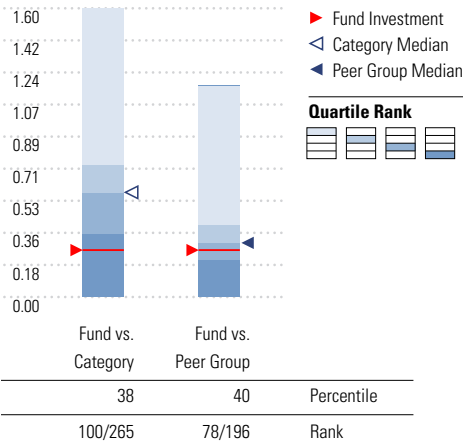

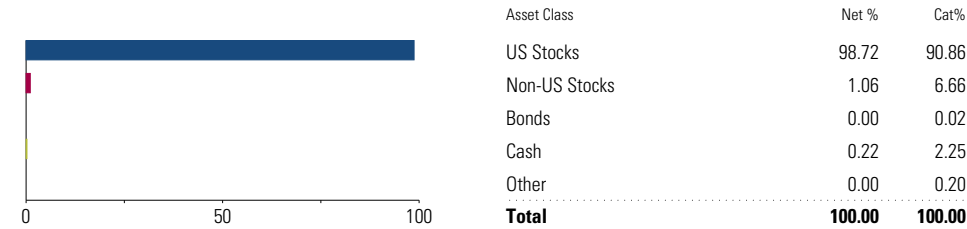

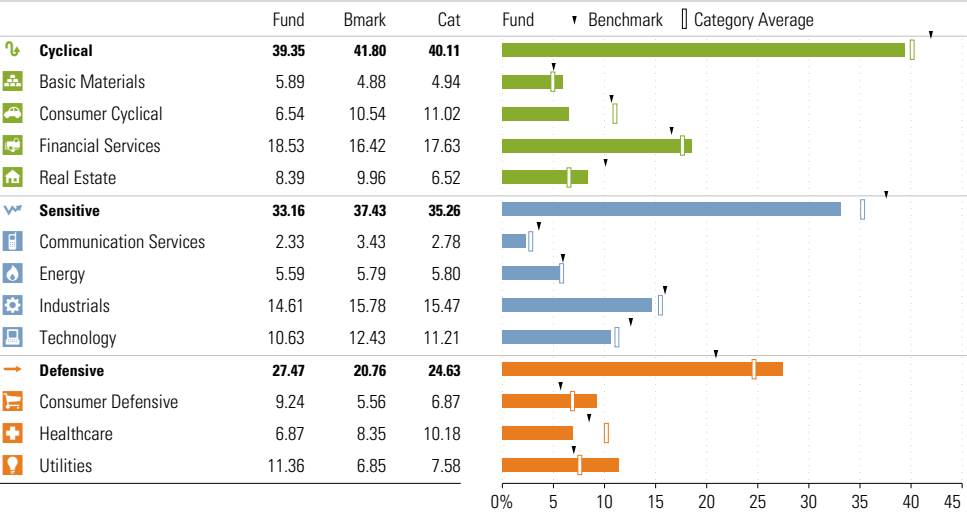

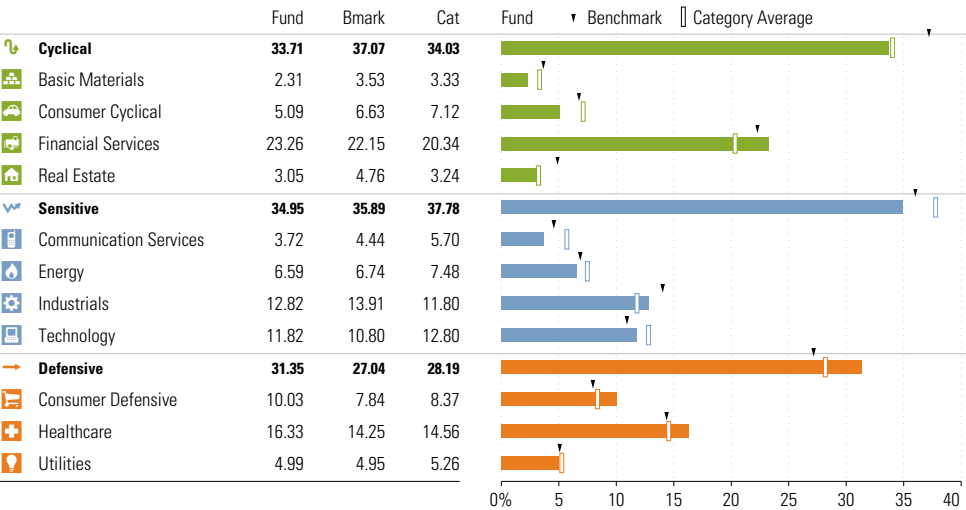
Style Breakdown
