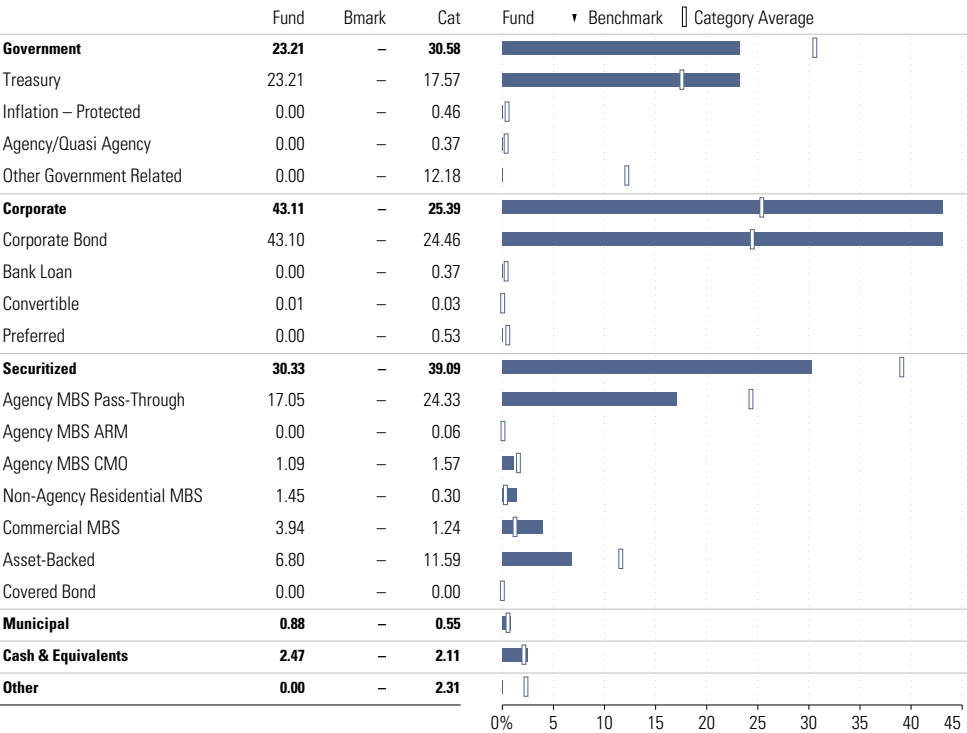

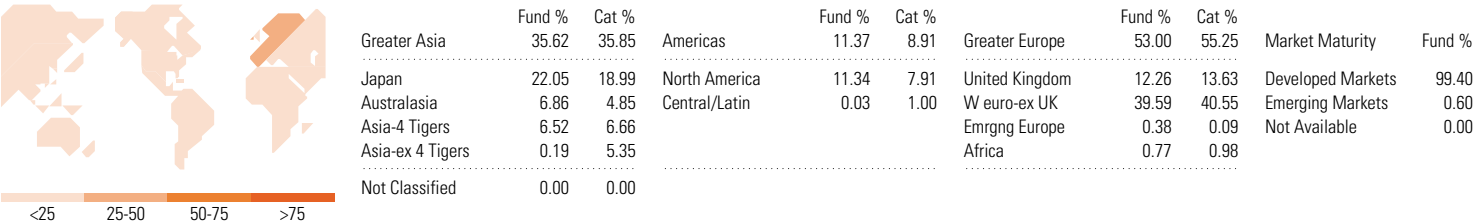
Asset Allocation as of 12-31-2024

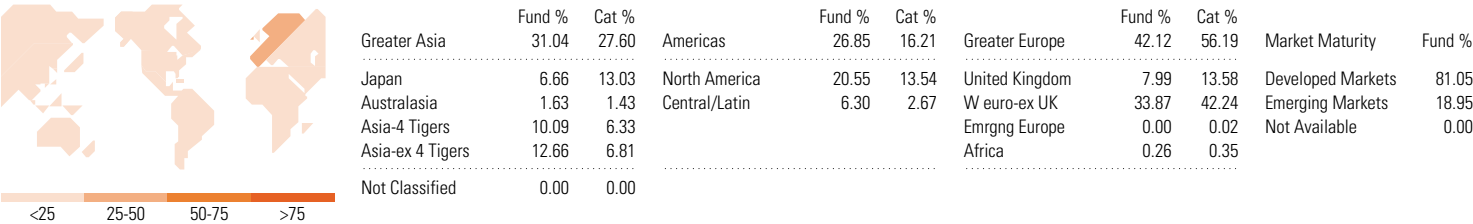
Asset Allocation as of 12-31-2024

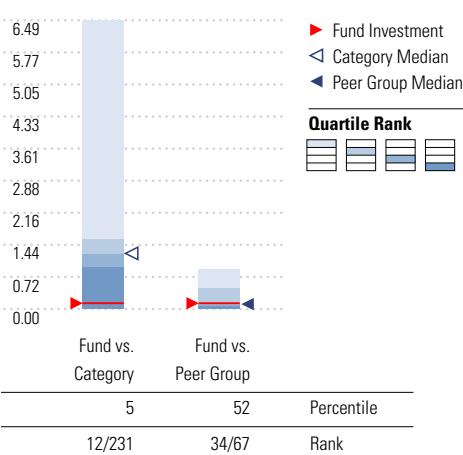

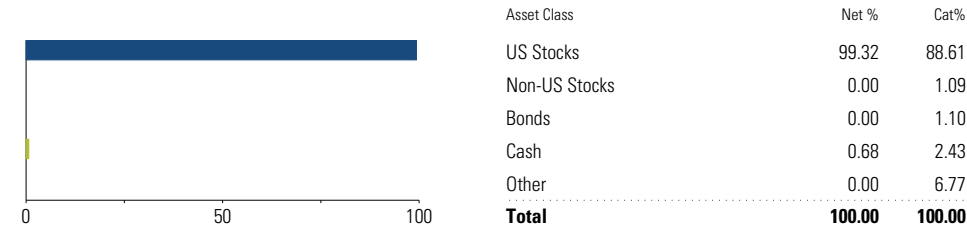

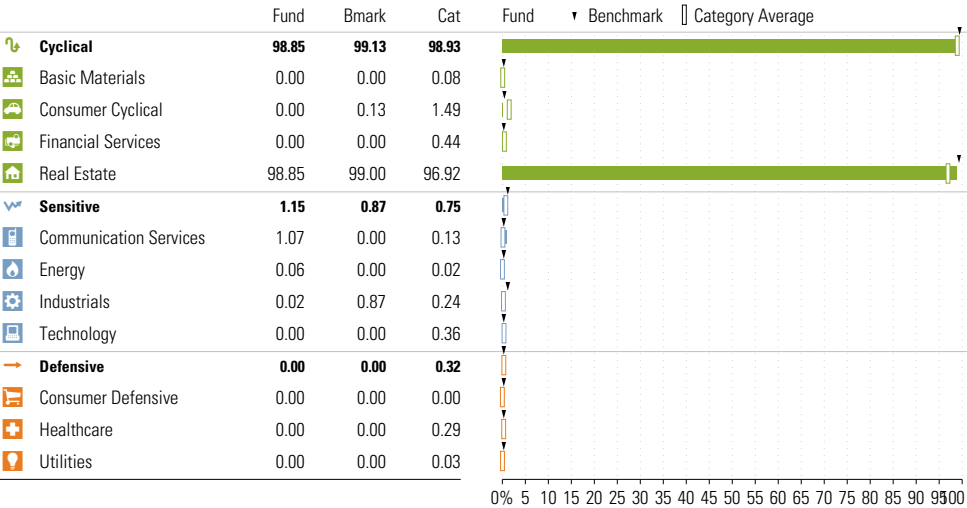
Style Breakdown

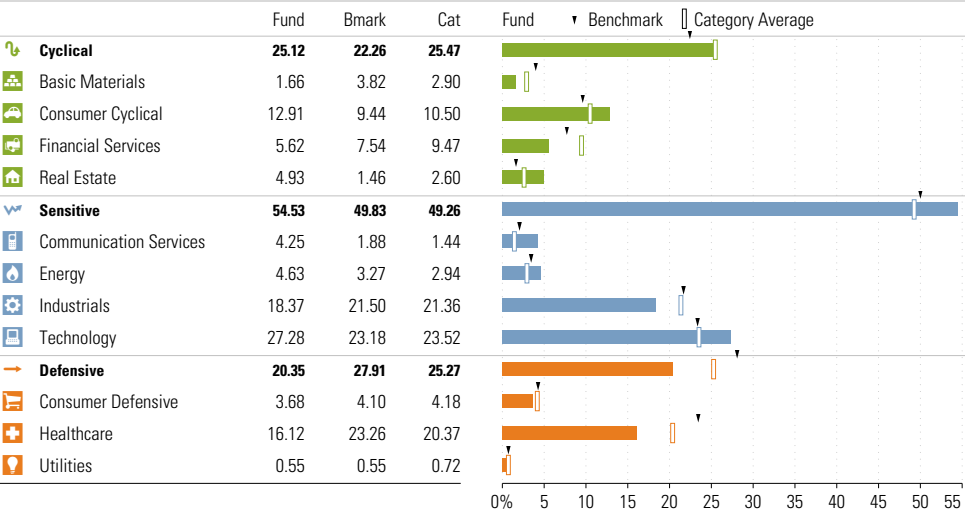
Style Breakdown

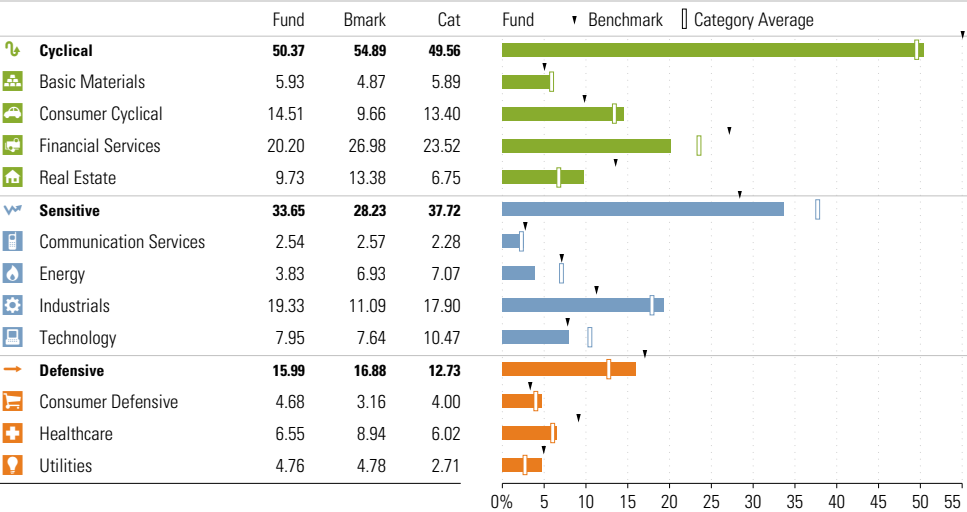

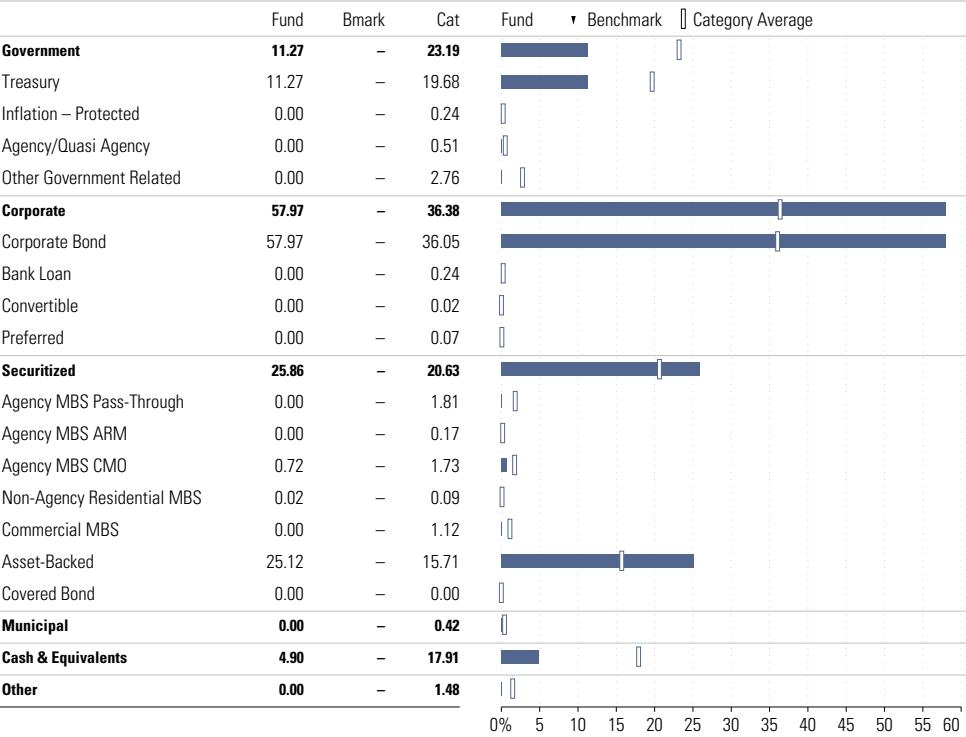
Asset Allocation as of 12-31-2024
