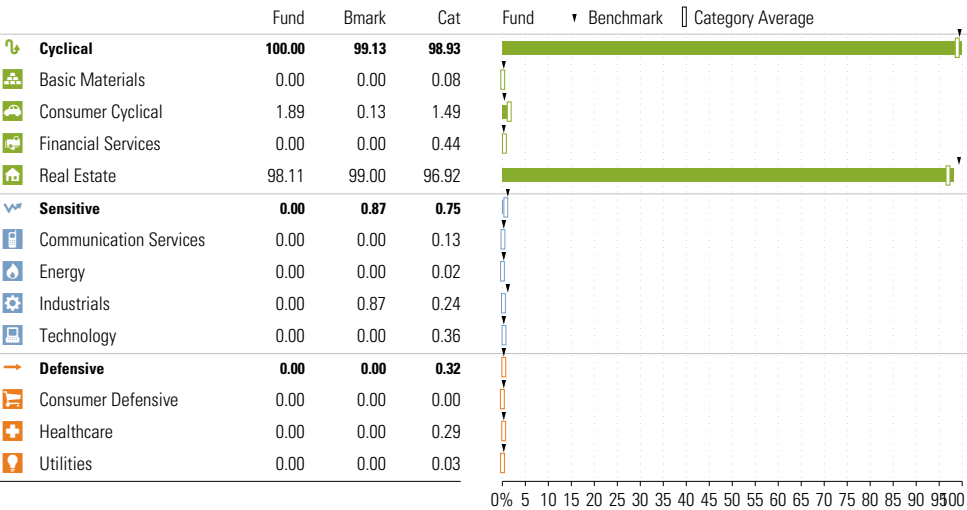

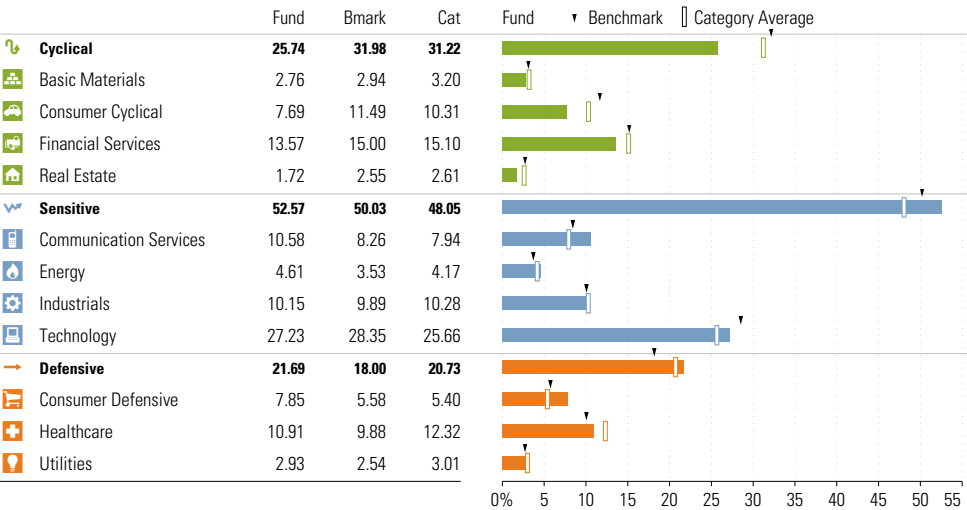

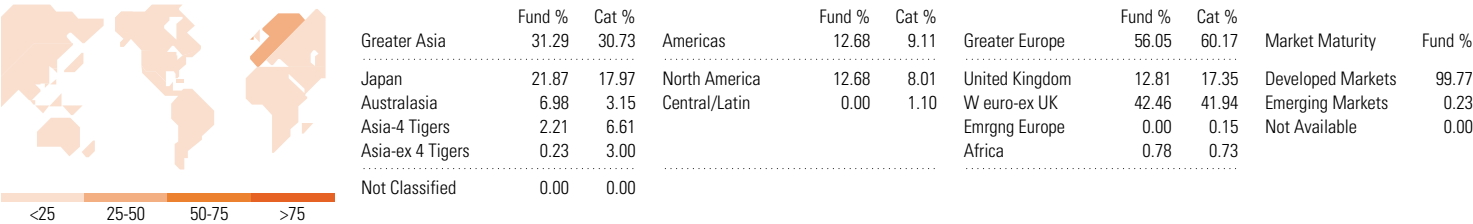
Asset Allocation as of 12-31-2024

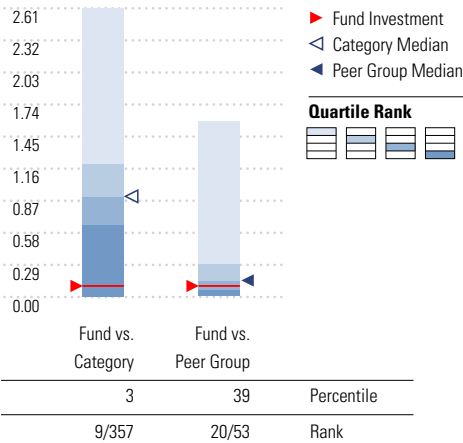
Growth of \$10,000

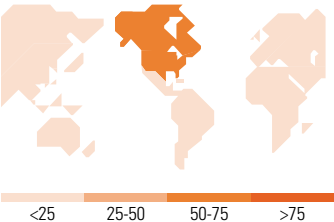

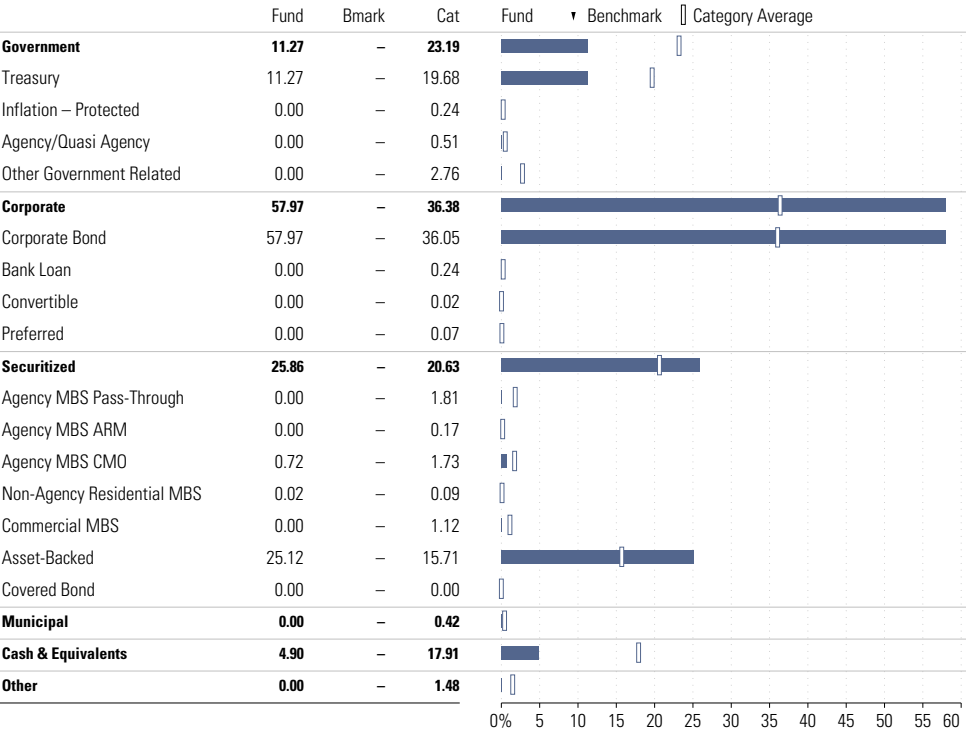
