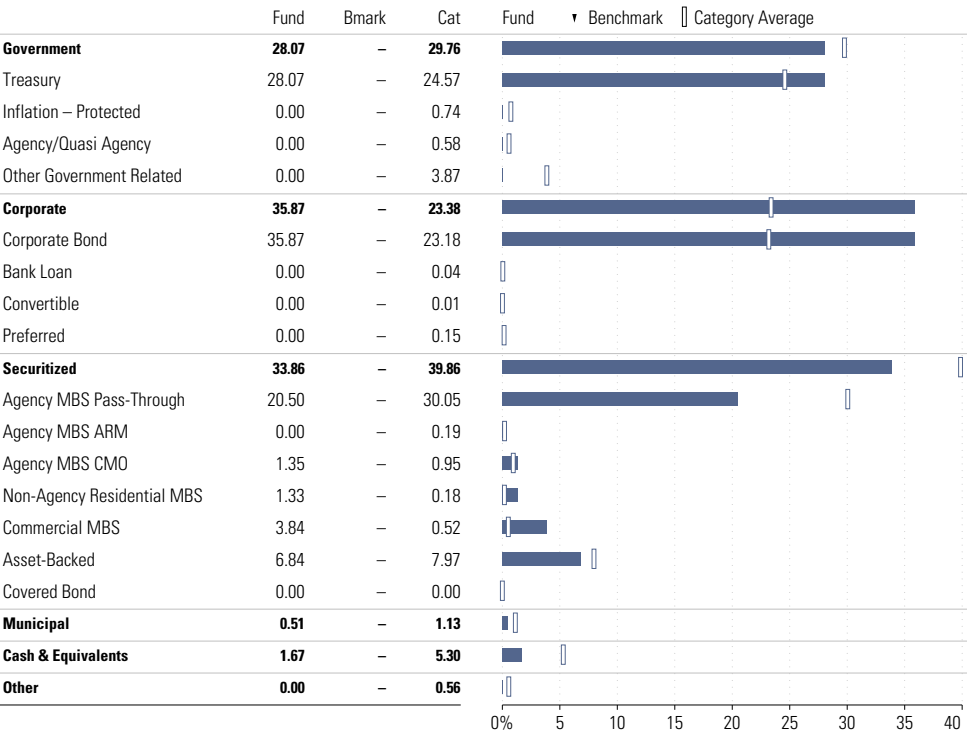

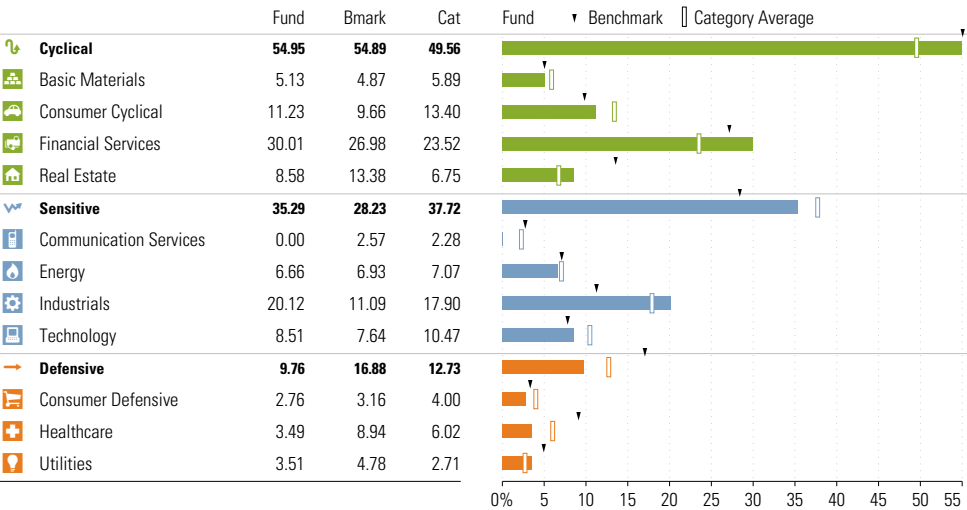

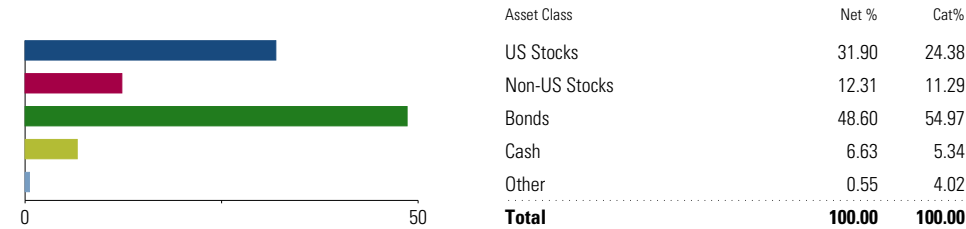

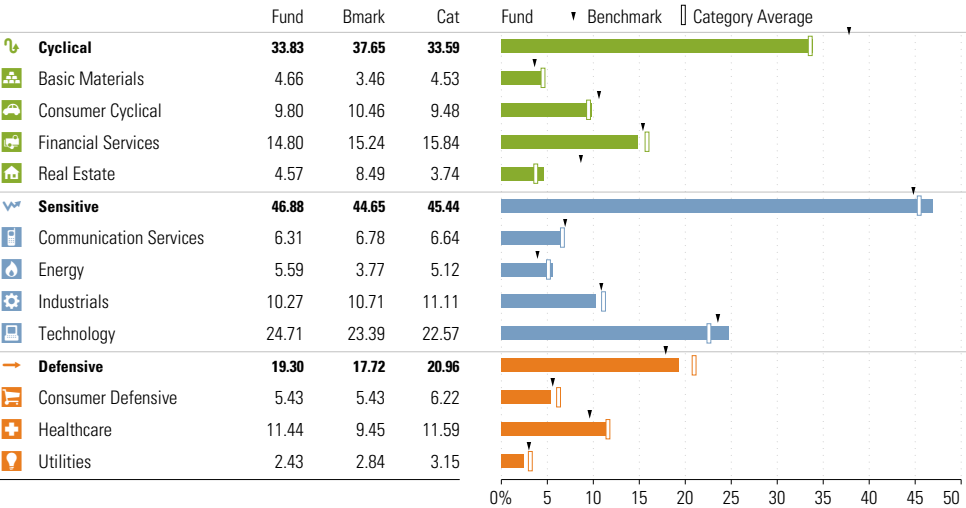

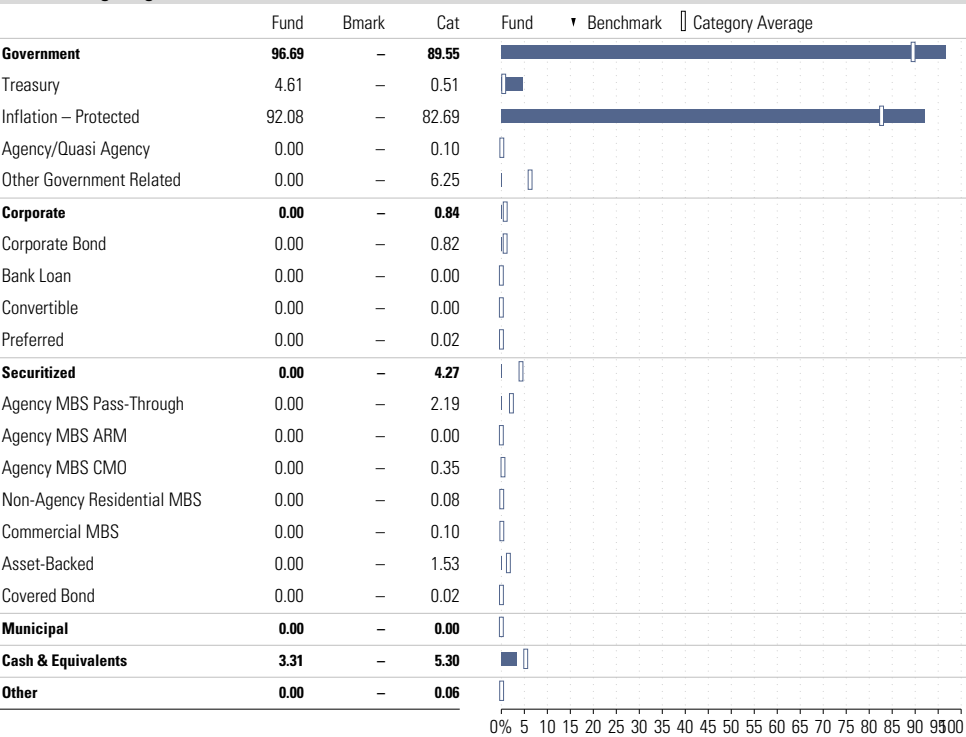

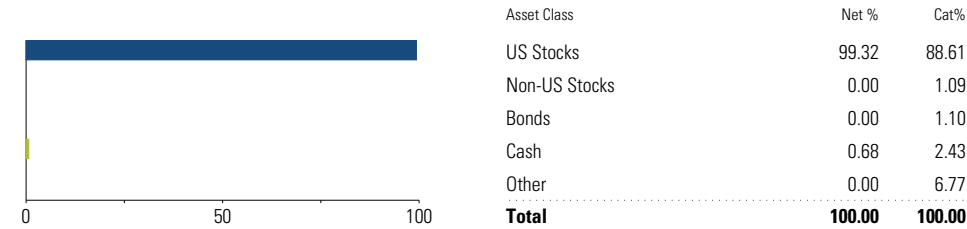

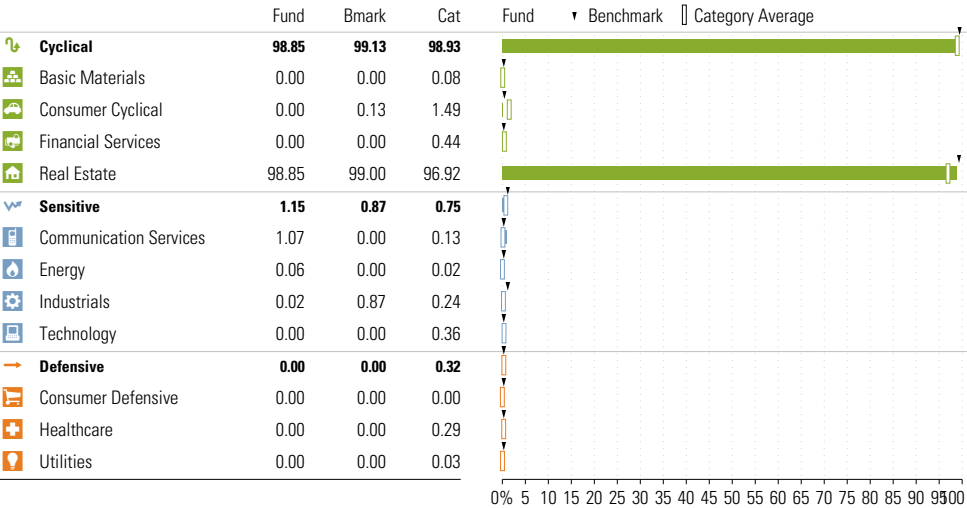
Style Breakdown

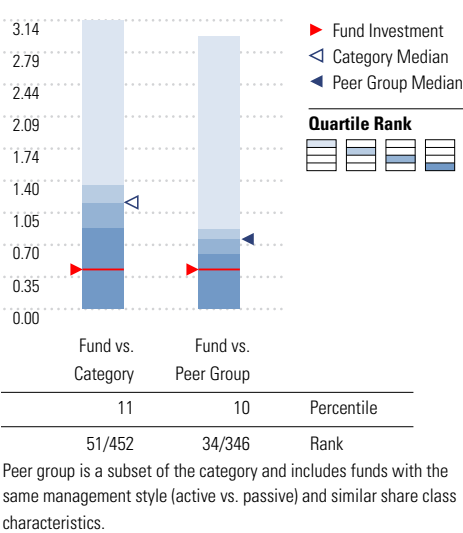

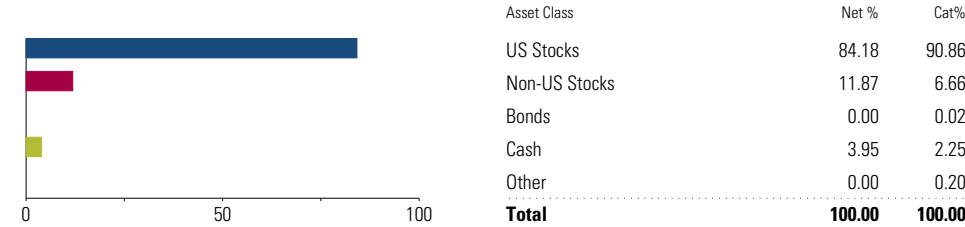

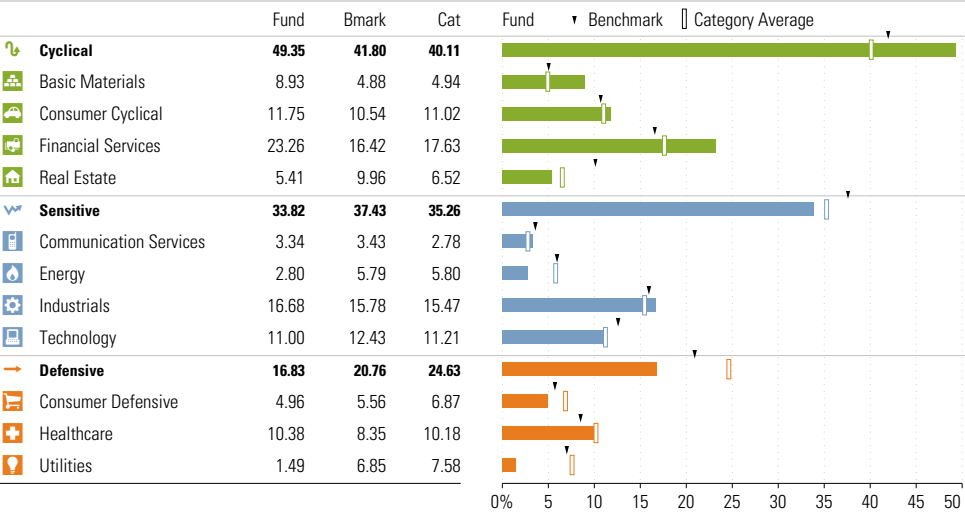

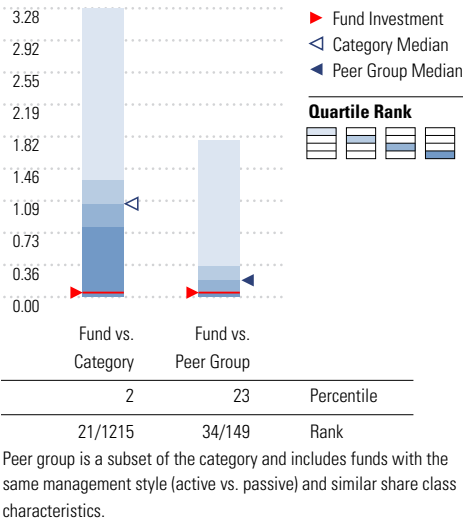

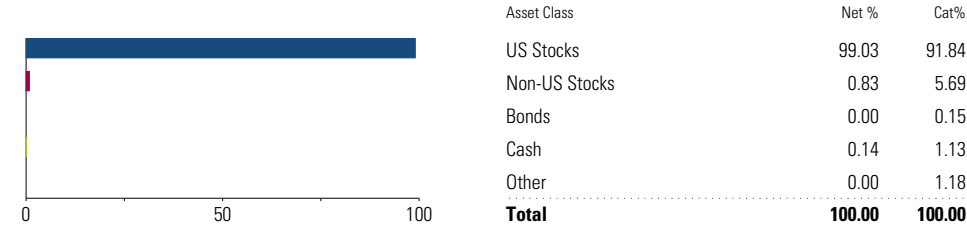

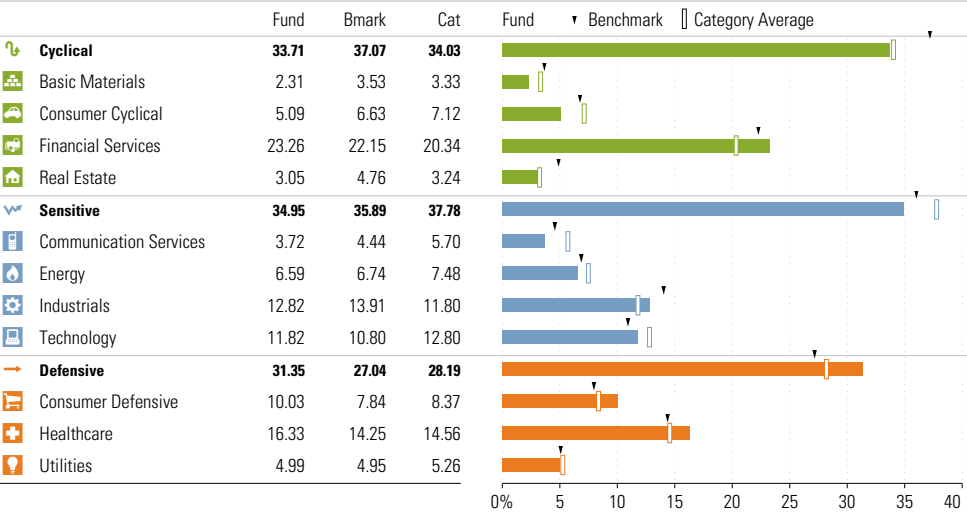
Style Breakdown
