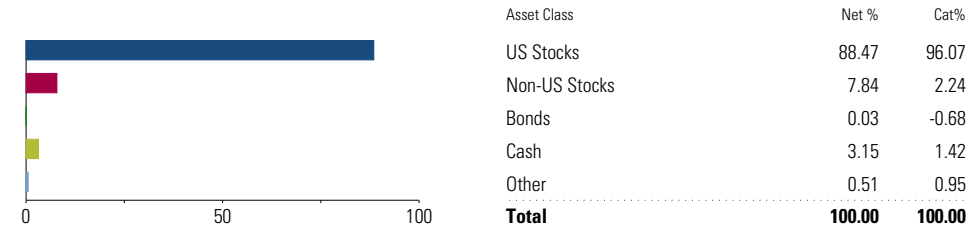

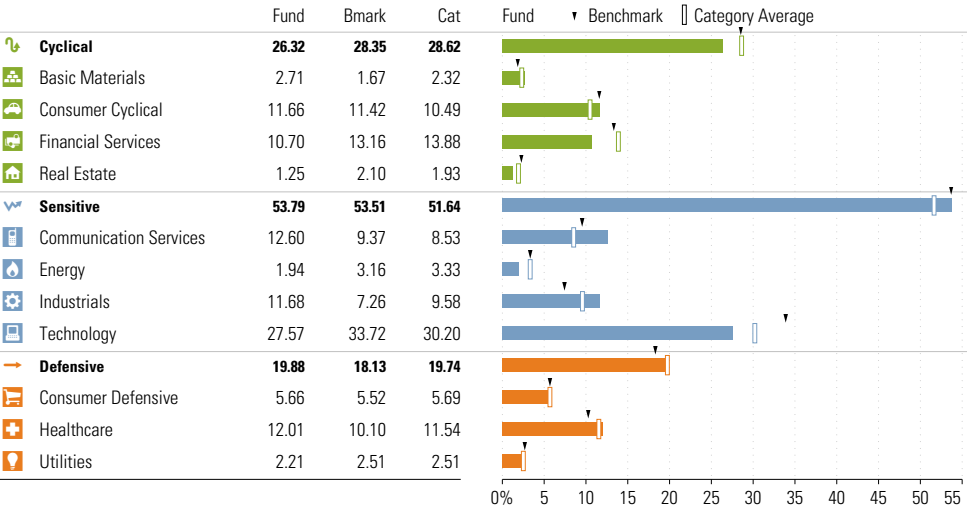

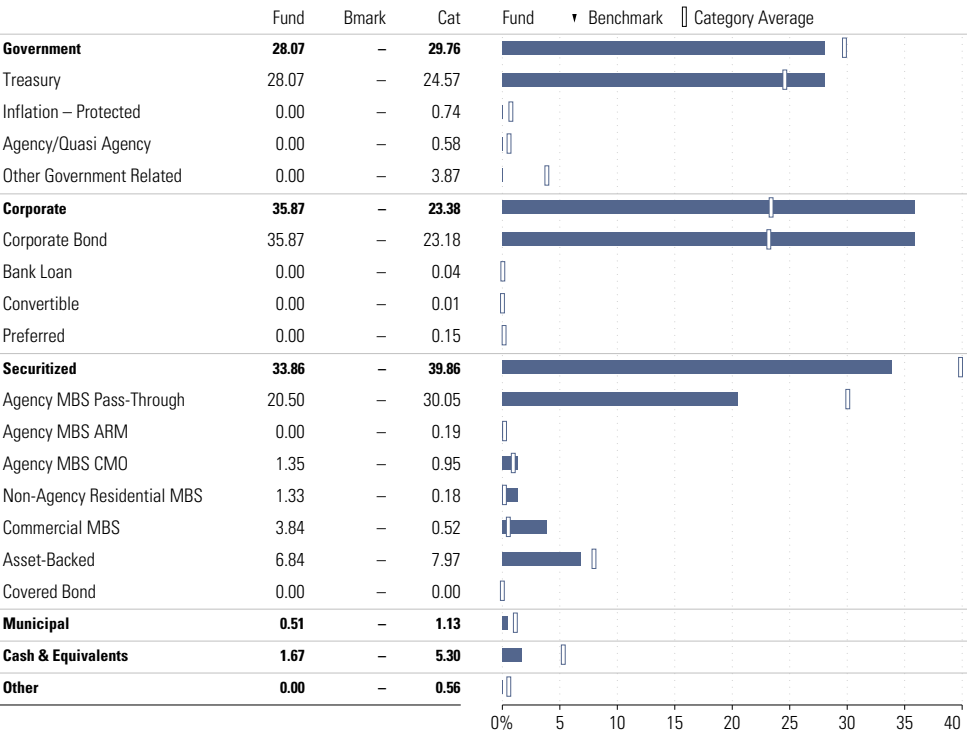

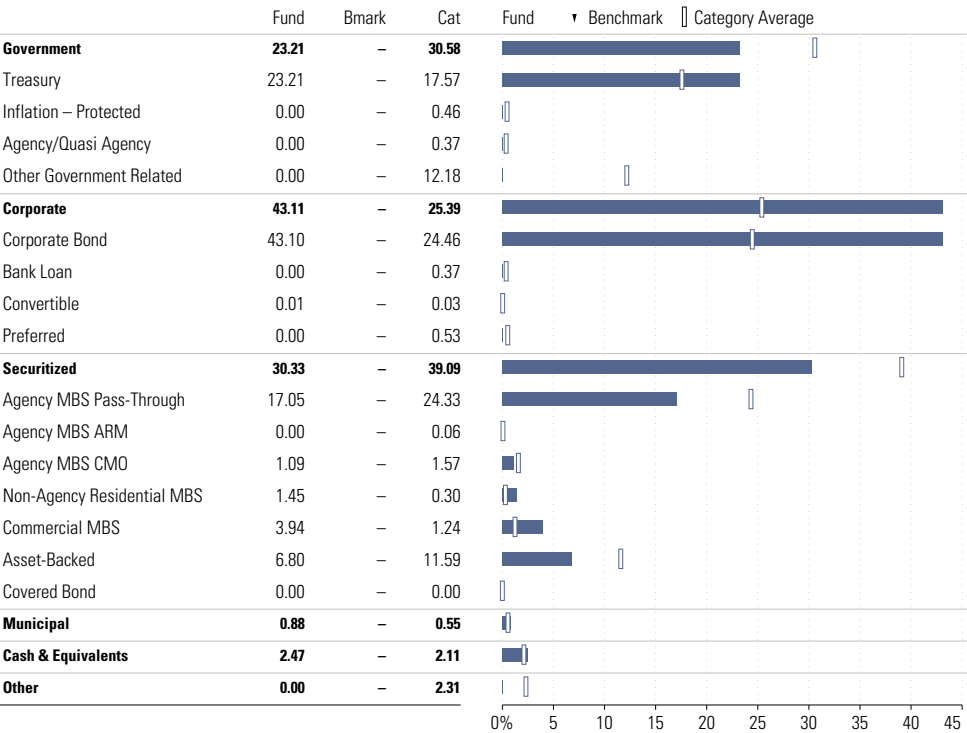

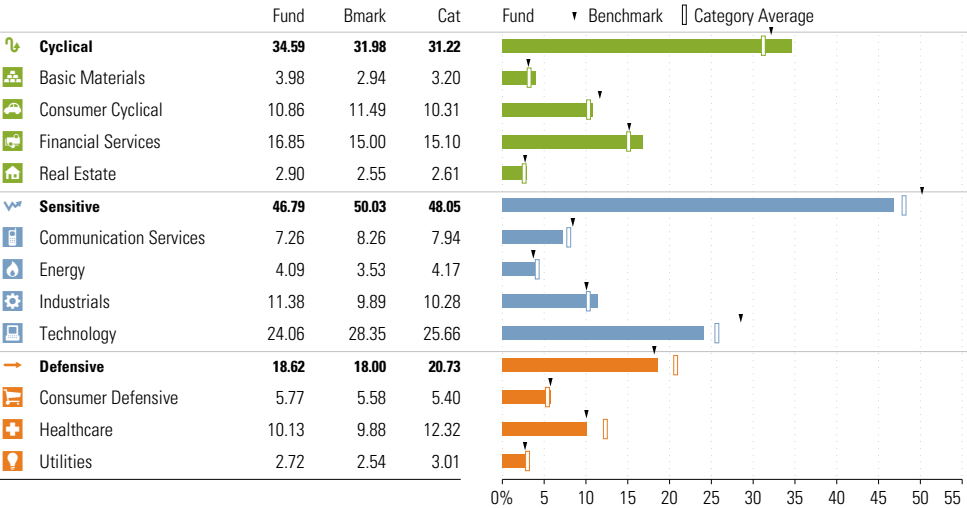
Style Breakdown
