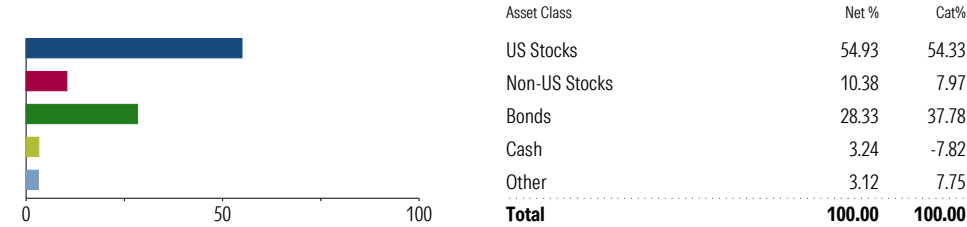

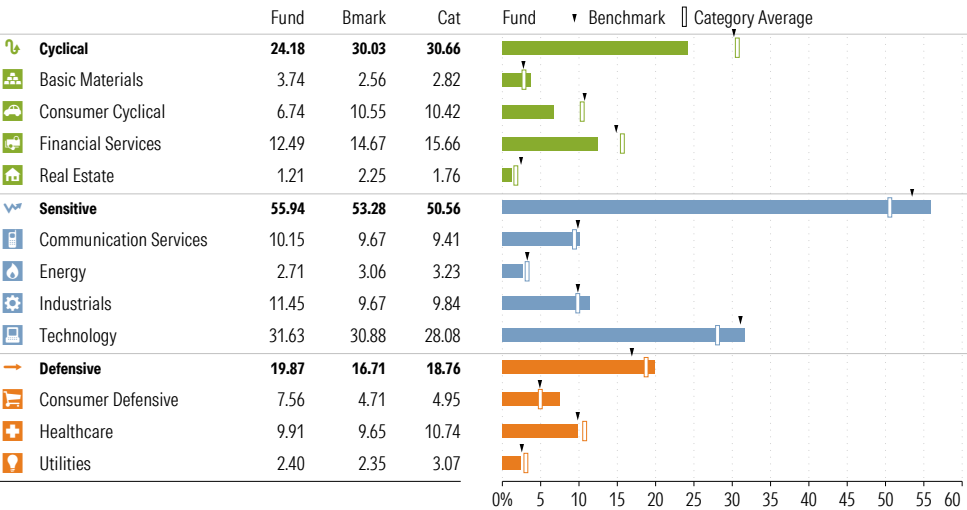

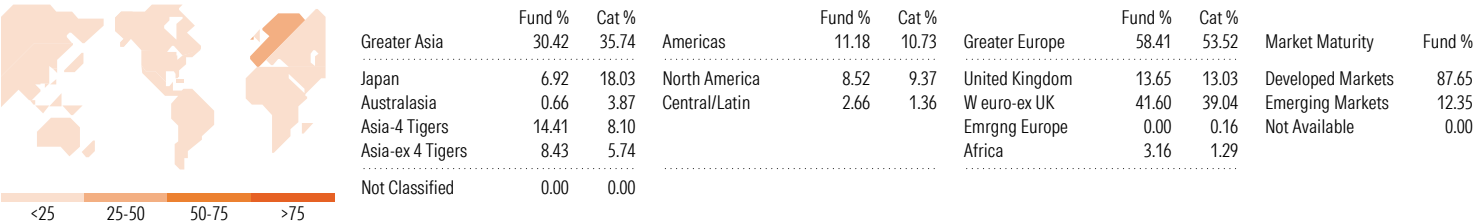
Asset Allocation as of 12-31-2025

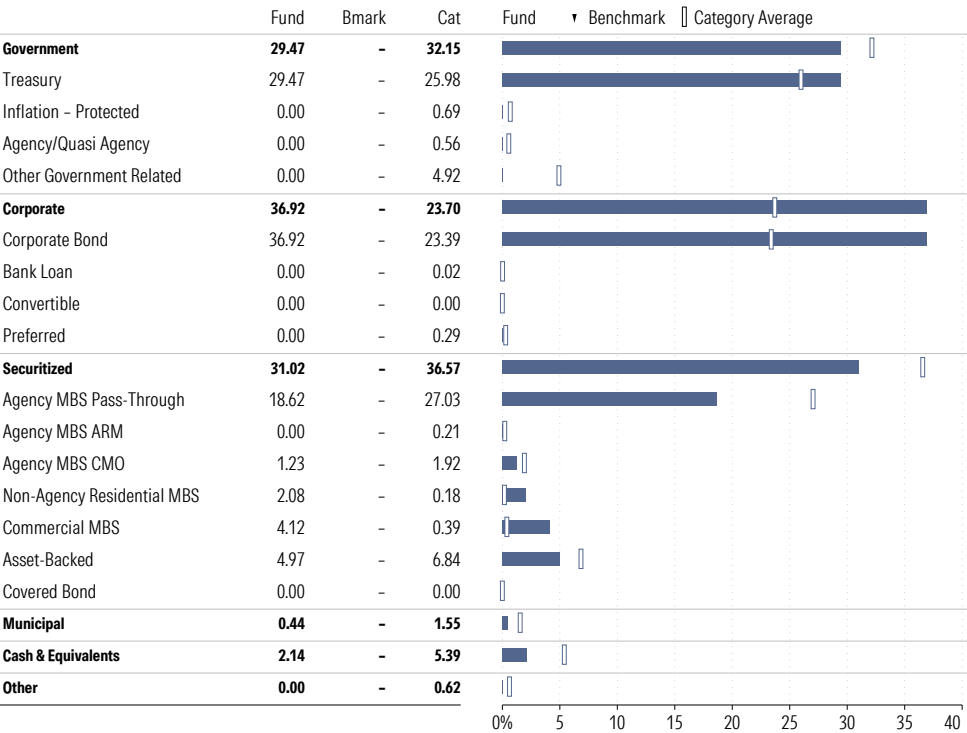

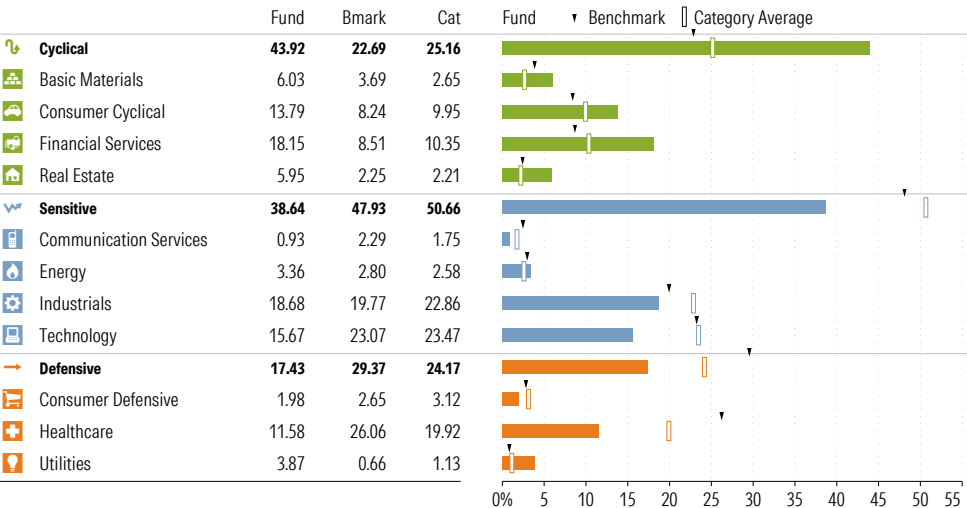

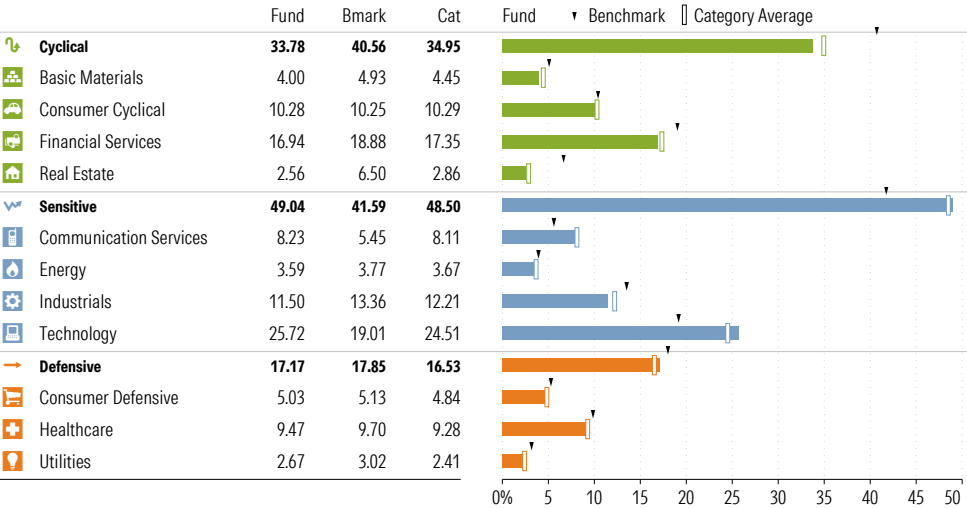
Style Breakdown

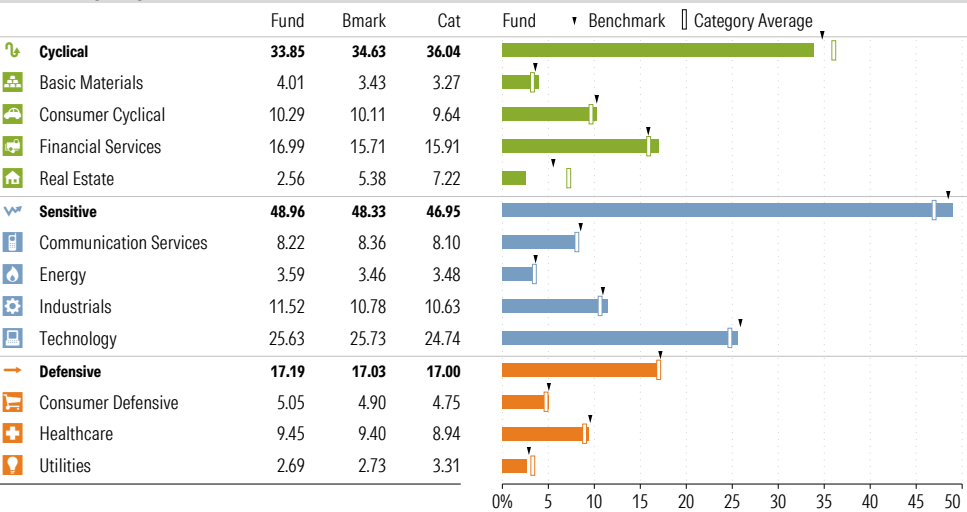
Style Breakdown
