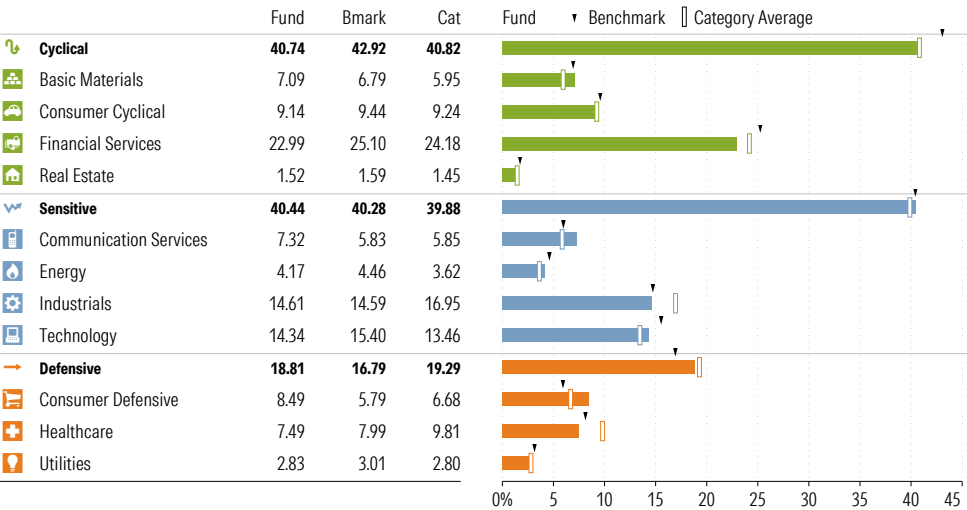

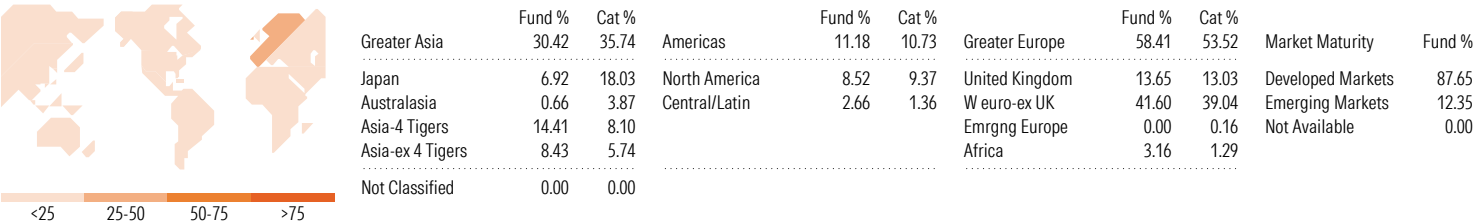

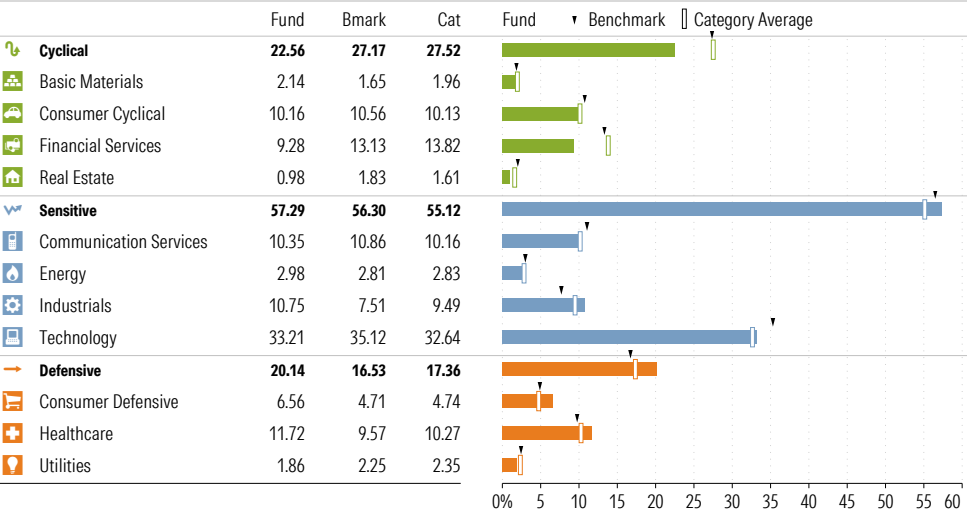

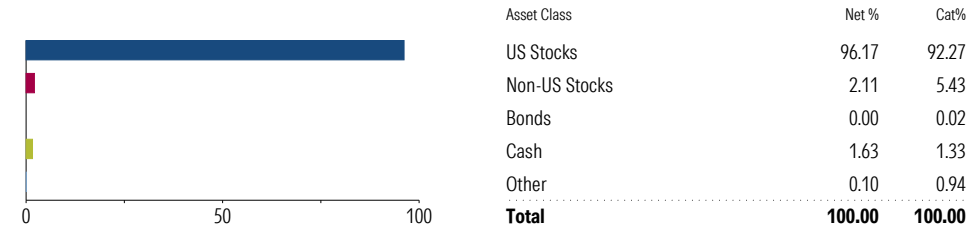

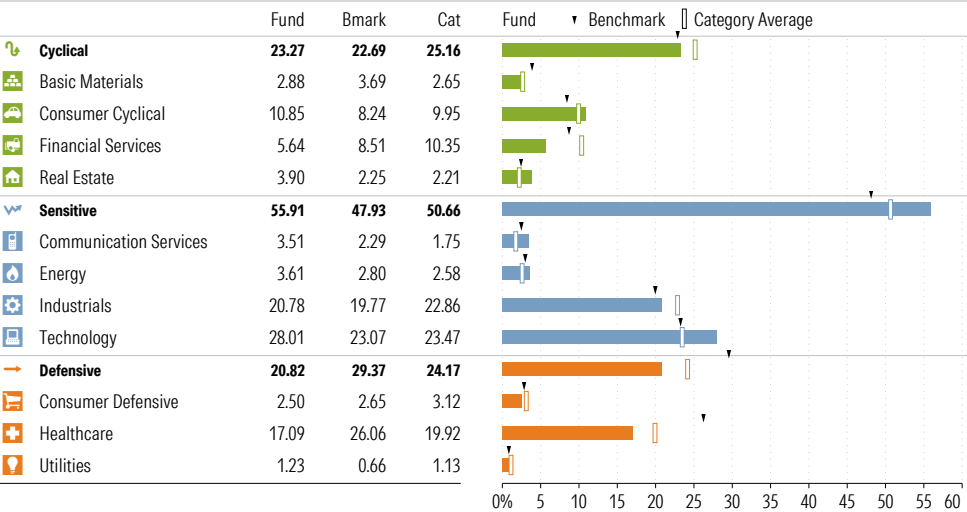

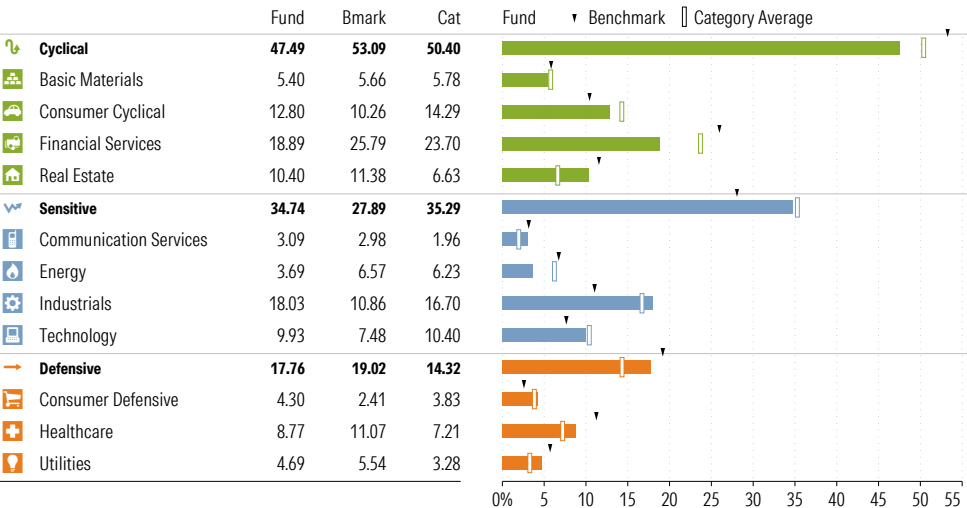

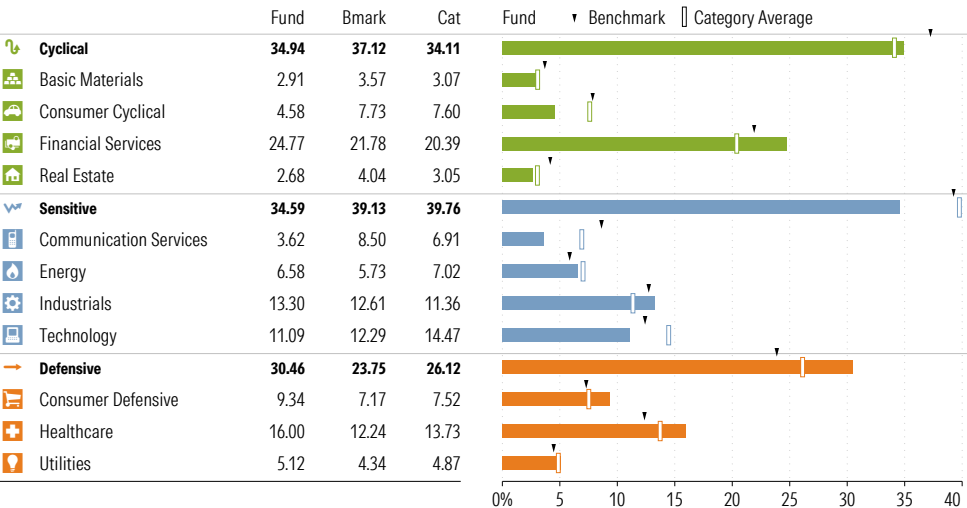
Style Breakdown
