We are placing this fund on watch for performance. While we expect the concentrated approach of longtime lead manager and firm founder Ron Baron, along with comanager Neal Rosenberg, to produce occasionally jagged performance patterns, the fund's recent underperformance is more extreme than we are accustomed to seeing. The fund experienced a nearly -12% loss through September-end 2025, while the category and index returned around 9%, and that follows two calendar years of bottom-quintile performance. Much of this year's poor results have been driven by losses in some of the fund's larger media and data-research holdings such as FactSet, Gartner, and MSCI. While the fund is on watch, we will monitor to see whether it can return to its historical levels of risk-adjusted return.

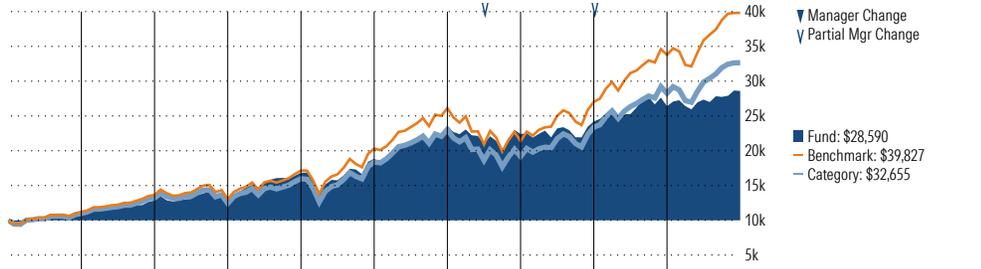
## Morningstar Investment Management LLC Analysis

We are placing Vanguard Dividend Growth on watch due to significant and persistent underperformance. The fund ranks in the bottom decile for 2023, 2024, and 2025, which has dragged down all trailing periods, including one-, three-, and five-year results. While the strategy's conservative approach has historically provided strong downside protection, such as top-decile performance in 2022's market pullback, it continues to lag in growth-driven markets and has underperformed even relative to other dividend-growth mandates. Given these challenges and its consistent shortfall versus its benchmark, we believe monitoring is warranted while recognizing the fund's quality-oriented approach may rebound in a market pullback.
